

Exclusion of certain Districts from Markets Order.

(ii.) The provisions of the Markets Order shall not apply to the following Districts (namely),—

County of Anglesey,
Borough of Beaumaris,
and the Markets Order shall be read and have effect as if those Districts had been included in the Schedule to that Order.

(FOOT-AND-MOUTH DISEASE.)

AT the Council Chamber, Whitehall, the 19th day of December, 1883.

By Her Majesty's Most Honourable Privy Council.

THE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Act, 1878, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows :

1. The following Area declared by Order of Council to be an Area infected with foot-and-mouth disease (namely),—the whole of the Liberty of the Isle of Ely, with the exception of the parishes of Haddenham, Wilburton, Stretham, Sutton, Thetford, Witchford, Wentworth, and Grunty Fen,—is, except such portion thereof as is included in the Area described in Article 2 of this Order, hereby declared to be free from foot-and-mouth disease, and the Area above described, except as aforesaid, shall, as from the commencement of this Order, cease to be an Area infected with foot-and-mouth disease.

2. The following Area (namely),—the whole of the Liberty of the Isle of Ely, with the exception of the parishes of Haddenham, Wilburton, Stretham, Sutton, Thetford, Witchford, Wentworth, Mepal, Downham, and Grunty Fen,—shall continue to be and is hereby declared to be an Area infected with foot-and-mouth disease.

3. This Order shall take effect from and immediately after the twentieth day of December, one thousand eight hundred and eighty-three.

(FOOT-AND-MOUTH DISEASE.)

THE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Act, 1878, and of every other power enabling them in this behalf, do hereby declare a meadow used for lairage situate at Trowse, in the borough of Norwich, in the occupation of Mr. Easto, together with the two adjoining meadows except certain sheds situate at the corner of one of the meadows, to be a Place infected with foot-and-mouth disease.

This Order shall take effect from and immediately after the twentieth day of December, one thousand eight hundred and eighty-three.

1. The Area described in the Schedule to this Order is hereby declared to be an Area infected with foot-and-mouth disease.

2. This Order shall take effect from and immediately after the twenty-second day of December, one thousand eight hundred and eighty-three.

SCHEDULE.

An Area in the parish of Loughton, in the petty sessional division of Epping, in the county of Essex, comprised within the following boundaries, that is to say, commencing at the Lamp Post at Church Hill, along Church-lane to the fields, thence in a straight line across the same to Chigwell-lane, along the west side of the same to Mr. Maitland's gate, through the old-road to the old Church, thence down the lane by Mr. Bottle's farm in a line to England-lane, along the same to the high-road and the east side of the same to Church Hill aforesaid.

THE Queen, taking into Her Royal consideration, that upon the decease of George Harry, Earl of Stamford and Warrington, without issue, which happened on the 2nd day of January last, the title and dignity of Earl of Stamford (the Earldom of Warrington having become extinct) devolved upon Harry, now Earl of Stamford, as the eldest son and heir of Harry Grey, Clerk, who was the only son and heir of John Grey, Esquire, commonly called the Honourable John Grey, the third son of Harry, fourth Earl of Stamford, whereby, according to the ordinary rules of honour, the sisters of the said Harry, now Earl of Stamford, cannot enjoy that place and precedence which would have been due to them had their father survived the said George Harry, Earl of Stamford and Warrington, and thereby succeeded to the title and dignity of Earl of Stamford, Her Majesty has been graciously pleased to ordain and declare that Mary, widow and relict of James Grant Lumsden, Esquire, late of the Bombay Civil Service, Frances Charlotte Elizabeth, wife of Joseph Rhodes Charlesworth, Clerk, Vicar of Elstead, in the county of Surrey, and Anna, widow and relict of William Rose Tredger, late of Sandown, in the Isle of Wight, Gentleman, shall henceforth have, hold, and enjoy the same title, rank, place, pre-eminence, and precedence as if their late father had succeeded to the title and dignity of Earl of Stamford :

And Her Majesty hath been further pleased to command that the said Royal order and declaration be recorded in Her Majesty's College of Arms.
