# By Her Majesty's Most Honourable Privy Council.

HE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Act, 1873, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows : "

1. The England and Wales Markets and Fairs Temporary Order of 1883 (in this Order referred to as the Markets Order) is hereby amended as follows :

Exclusion of certain Districts from Markets Order.

The provisions of the Markets Order shall not apply to the following Districts (namely),-

County of Northumberland, Borough of Berwick-upon-Tweed,

Borough of Morpeth, Borough of Newcastle-upcn-Tyne, Borough of Tynemouth,

and The Markets Order shall be read and have effect as if those Districts were included in the Schedule to that Order.

2. This Order may be cited as The England and Wales Market; and Fairs Temporary Order of 1883, Amendment No. 5.
