(FOOT-AND-MOUTH DISEASE.)

A^T the Council Chamber, Whitehall, the 2nd day of April, 1884.

By Her Majesty's Most Honourable Privy Council.

THE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Act, 1878, and of overy other power enabling them in this behalf, do order, and it is hereby ordered, as follows :

1. The following Area declared by Order of Council dated the sixth day of March, one thousand eight hundred and eighty-four, to be an Area infected with foot-and-mouth disease (namely),in the counties of Westmorland and Cumberland, comprised within the following boundaries, that is to say, from the bridge over the river Eamont and the east side of the road to the Crown Hotel at Eamont Bridge, from there to a point opposite Southwaite Green Mill, following the south side of the road leading from Eamont to Yanwath to a field called Sutton Field adjoining the said road and now in the occupation of Mr. John Hodgson, thence along the outside north-west boundary of the lands occupied by the said John Hodgson and Lord Brougham and Vaux, thence in a direct line to Hughs Crag Bridge, thence along the north side of the London and North-Western Railway and of the Eden Valley Railway to the Bridge over the Railway at Weatheriggs Tilcry, from the said Bridge on the north-west corner of the Plantation of Lord Hothfield called Leicet Wood, thence along the wall of the field of Mr. Richard Richardson to Whinfell Great Wood, thence following the stone wall dividing the farms of Mr. Richard Richardson and Mr. Thomas Mitchell to a point where Mr. Hutchinson's farm comes in, thence by a fence which divides the farms of Mr. Mitchell and Mr. Hutchinson to the main-road called the Temple Sowerby-road, crossing the main-road and on by the fence dividing the said farms to the river Eamont, thence along the river Eamont, thence crossing the Eamont opposite the east side of the Plantation of Lord Lonsdale called Dasons Scar, thence by the stone wall dividing Frenchfield and Sceugh farms to the Edenhallroad, thence by the south side of the said road to the village of Carleton, thence following the south side of the road leading from Carleton to Eamont Bridge,---is, except such portion thereof as is included in the Area described in Article 2

of this Order, hereby declared to be free from foot-and-mouth disease, and the Area above described, except as aforesaid, shall, as from the commencement of this Order, cease to be an Area infected with foot-and-mouth disease.

2. The following Area (namely),—so much of the county of Westmorland as is comprised within the following boundaries, that is to say, from the lowest point of Brougham Castle farm on the right bank of the river Eamont, along the fence dividing this farm from Mr. Mitchell's Whinfell Park farm to the Lightwater Stream, then by the left bank of this stream to the south side of Temple Sowerby-road, then along the wall to the corner of the wall bounding Mrs. Croome's Great Pas-ture, following this wall southwards to the Fremington-road, there crossing to the south side of the road and by the east fence of Fremington to the Pembroke House farm east fence, thence by the fence bounding Lord Brougham's Narrow Plantation to a straight fence running northwards to Pembroke House, passing twenty yards from the farm buildings and crossing the road at the west corner of the stackyard to the Brougham Park wall, then following the said wall to the river Lowther and along the right bank of the river to a point opposite the centre of Pembroke House Holme, then crossing the river and by a straight line of fence to the nearest point on the river Eamont, thence along the right bank of this river to the point first-mentioned,-shall continue to be and is hereby declared to be an Area infected with foot-and-mouth disease.

3. This Order shall take effect from and immediately after the fourth day of April, one thousand eight hundred and eighty-four.

2. The following Area (namely),—the town-ship of Loughton-en-le-Morthen in the Rotherham District of the Upper Strafforth and Tickhill petty sessional division in the West Riding of the county of York,-shall continue to be and is hereby declared to be an Area infected with footand-mouth disease.

3. This Order shall take effect from and immediately after the fourth day of April, one thousand eight hundred and eighty-four.

But others from non-Egyptian ports beyond the Suez Canal will not receive pratique unless they have purged their quarantine at an intermediate port. The prohibition, however, to the introduction of soiled clothes and rags continues in force."

(No. 59.)-BALTIC.-Sweden-South COAST. (1.) Carlshrona Harbour prohibited Anchorage

near Telegraph Cable. THE Swedish Government has given notice, that a telegraph cable has been laid from a position on the eastern side of East Kruthusholm King's Holm, in communication by cable with Carlskrona), to a position on the western side of Basareholm, Carlskrona Harbour.

The shore ends of both cables are marked by poles about 20 feet high, and surmounted by a red cross, under which there is a large white

notice, with Telegraf-Kabel in black letters on it. Mariners are cautioned not to anchor in the vicinity.

EAST COAST-KALMAR SUND.

(2.) Grimskär-Re-Exhibition of Permanent Lights.

Also, with reference to Notices to Mariners, No. 15 (6), of 16th January, 1884, and No. 34 (2), of 7th February, 1884, on discontinuance of the permanent lights at Grimskär, and exhibition of a provisional light, pending re-building the lighthouse.

Further notice has been given, that the lighthouse having been re-built, the permanent lights would be re-exhibited on the 12th March, 1884.

The upper light shows a single red flash between the bearings of N. 49° E. and N. 31° E.; a fixed white light from N. 31° E. to N. 19° E.; and a double white flash from N, 19° E. to N. 1° E. It is elevated 55 feet above the sea, and should be visible in clear weather from a distance of about 13 miles.

The lower light shows a double white flash between the bearings of S. $32\frac{1}{5}^{\circ}$ W. and S. $36\frac{1}{5}^{\circ}$ W. ; a fixed white light from S. $36\frac{1}{5}^{\circ}$ W. to S. 38° W. ; a single red flash from S. 38° W. to S. 48° W. ; and a fixed red light from S. 48° W. to S. 58° W. It is elevated 45 feet above the sea, and should be visible in clear weather :- the white light from a distance of about 12 miles, the red light, from about 8 miles.

The illuminating apparatus is dioptric, or by lenses.

These lights are obscured in all directions other than above given; but the lower light may be faintly visible through a window on the east side of the lighthouse, when near it.

The lighthouse will shortly be painted white.

The small leading light on the north-east point of Grimskär, which serves as a guide to Kalmar Road, is not altered ; but shows as heretofore-a red light between the bearings of S. 60° W. and S. 80° W., and a white light to the northward and southward.

[The bearings are magnetic. Variation 8° Westerly in 1884.]
