amongst other things enacted that Her Majesty may, with the advice of Her Privy Council, order the calling out of all or any part of the Militia

to be dispensed with:

And whereas it has seemed fit to Her Majesty, by and with the advice of Her Privy Council, to dispense with the calling out of the 3rd (Militia) Battalion, Berkshire Regiment, and to direct that there shall be no training and exercising thereof in the year one thousand eight hundred and

eighty-four:

Now therefore, Her Majesty, by and with the advice of Her Privy Council, doth hereby dispense with the calling out of the 3rd Battalion, Berkshire Regiment, and doth order and direct that there shall be no training and exercise thereof in the year one thousand eight hundred and eightyfour, and this Order be published in the London Gazette. HEREAS the Honourable Thomas Henry William Pelham, Barrister-at-Law, duly appointed in pursuance of the Municipal Corporations Act, 1882, as Commissioner for the purpose of determining the boundaries of the Wards of the Borough of Scarborough, and of apportioning the Councillors thereto, transmitted to one of Her Majesty's Principal Secretaries of State, his determination and apportionment in the following terms :-

" Municipal Corporations Act, 1882.

" (45 and 46 Vict. c. 50.) "Borough of Scarborough.

"WHEREAS Her Majesty has been pleased by and with the advice of Her Privy Council, and in pursuance and exercise of the power vested in Her Majesty by the Municipal Corporations Act, 1882, to fix the number of Wards into which the Borough of Scarborough shall be divided, and to order and direct that the said Borough shall be divided into six wards, which order was made on

the second day of February, 1884.

"And whereas on the twenty-fifth day of March, 1884, the Right Honourable Sir William Vernon Harcourt, one of Her Majesty's Principal Secretaries of State, in pursuance of the 30th section of the said Act, did duly appoint the Honourable Thomas Henry William Pelbam, Barrister-at-Law, to be a Commissioner to prepare a scheme for determining the boundaries of such Wards, and for apportioning the Councillors of the said Borough among such Wards as in the said Act mentioned.

" Now I the said Thomas Henry William Pelham, do hereby in pursuance of the powers given me by virtue of the said appointment under the said Act, determine as hereinafter mentioned the boundaries of the six Wards into which the said Borough is to be divided, which Wards are hereinafter numbered and named as follows, that

is to say:

"Ward No. 1 otherwise the North Ward.

"Ward No. 2 otherwise the North-West Ward.

- " Ward No. 3 otherwise the Central Ward.
- " Ward No. 4 otherwise the East Ward. "Ward No. 5 otherwise the West Ward.
- " Ward No. 6 otherwise the South Ward.

"And I do hereby determine that the said Ward No. 1, otherwise the North Ward, shall comprise so much of the Borough of Scarborough as is contained within a line commencing at a

point in the Borough boundary on the foreshore opposite the northern extremity of the Castle, and proceeding thence in a south-westerly direction along the north-western boundary of the Castle Yard to a point in the centre of Castle-road in the main entrance of the Castle, and thence in a westerly or south-westerly direction along the centre of Castle-road to the junction of Castleroad with Cemetery-road, and thence along the centre of Cemetery-road to the point where the said road crosses the Borough boundary, and thence in a north-easterly and easterly direction along the northern boundary of the Borough to the point of commencement before described.

"And I do hereby determine that the said Ward No. 2, otherwise the North-West Ward, shall comprise so much of the Borough of Scarborough as is contained within a line commencing at a point in the Borough boundary in the centre of Cemetery-road, and proceeding thence in an easterly direction along the centre of Cemeteryroad to the junction of Cemetery-road with Castle-road and thence in a south-westerly direction along the centre of Castle-road and Victoria road to the junction of Victoria-road with Falsgrave - road, and thence along the centre of Falsgrave-road to a point in the centre of the said last-mentioned road immediately over the centre of the Scarborough and Whitby Railway line, and thence in a north-westerly direction above or along the centre of the said railway line to where the said railway line crosses the Borough boundary, and thence in a northeasterly direction along the Borough boundary to the point of commencement above described.

And I do hereby determine that the said Ward No. 3, otherwise the Central Ward, shall comprise so much of the Borough of Scarborough as is contained within a line commencing at a point in the Borough boundary on the foreshore opposite the centre of the road known as Bland's Cliff, and proceeding thence up the centre of the said Bland's Cliff, St. Helen's-square, Cross-street and Auborough-street to the junction of Auborough-street with Castle-road, thence in a south-westerly direction along the centre of Castle-road and Victoria-road to the junction of Victoria-road with Falsgrave-road, and thence along the centre of Falsgrave-road to a point in the centre of Falsgrave-road opposite the centre of the road known as Belgrave-terrace, thence in a south easterly direction along the centre of Belgraveterrace and across the railway bridge to the centre of Westwood-road, thence in a north-easterly direction along the centre of Westwood-road, to a point opposite the centre of the Park Entrance, thence in a southerly direction along the centre of the north roadway of the Park to a point in the centre of the Ramsdale Valley-road and thence in an easterly direction along-the centre of the Ramsdale Valley-road and of the roadway over the Aquarium to a point in the Borough boundary on the foreshore opposite to the centre of the said last-mentioned roadway, and thence in a northerly direction along the Borough boundary to the point of commencement before described.

"And I do hereby determine that the said Ward No. 4, otherwise the East Ward, shall comprise so much of the Borough of Scarborough as is contained within a line commencing at a point in the Borough boundary on the foreshore opposite to the centre of the road known as Bland's Cliff, and proceeding thence up the centre of the said Bland's Cliff, St. Helen's-square, Cross-street, and Auborough - street to the junction of Auborough-street with Castle-road, and thence in
