PRESENT.

The QUEEN's Most Excellent Majesty in Council.

HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the sixth and seventh years of His Majesty King William the Fourth chapter seventy-seven of the Act of the third and fourth years of Her Majesty chapter one hundred and thirteen of the Act of the fourth and fifth years of Her Majesty chapter thirty-nine of the Act of the thirtyfirst and thirty-second years of Her Majesty chapter one hundred and fourteen of the Act of the thirty-third and thirty-fourth years of Her Majesty chapter thirty-nine and of the Act of the thirty-seventh and thirty-eighth years of Her Majesty chapter sixty-three duly prepared and laid before Her Majesty in Council a scheme, bearing date the twenty-fourth day of April, in the year one thousand eight hundred and eight-four, in the words and figures following; that is

to say:—
"We the Ecclesiastical Commissioners for England in pursuance of the Act of the sixth and seventh years of His Majesty King William the Fourth chapter seventy-seven, of the Act of the third and fourth years of Your Majesty chapter one hundred and thirteen, of the Act of the fourth and fifth years of Your Majesty chapter thirty-nine, of the Act of the thirty-first and thirty-second years of Your Majesty chapter one hundred and fourteen of the Act of the thirty-third and thirty-fourth years of Your Majesty chapter thirty-nine and of the Act of the thirty-seventh and thirty-eighth years of Your Majesty chapter sixty-three have prepared and now humbly lay before Your Majesty in Council the following scheme for effecting the transfer of the patronage or right of nomination of and presentation to a certain benefice to wit the new parish of Saint George Barrow in the county palatine of Lancaster and in the diocese of Carlisle and for altering the existing boundary between the two Archdeaconries of Carlisle and of Westmorland within the said diocese of Carlisle by the substraction of the rural deanery of Keswick from the Archdeaconry of Carlisle and the addition thereof to the area of the Arch-deaconry of Westmorland and for dividing the area of the said Archdeaconry of Westmorland when so enlarged into two archdeaconries by

archdeaconry in manner hereinafter mentioned.

"Whereas by an indenture bearing date the fourth day of October one thousand eight hundred and sixty-seven and made between the Most Noble William Duke of Devonshire of the first part, William Currey of the second part, and the said William Duke of Devonshire the Most Noble Walter Francis Duke of Buccleuch and Queens-berry the Right Honourable Frederick Charles Cavendish commonly called Lord Frederick Charles Cavendish Henry William Schneider and Sir James Ramsden, Knight, then James Ramsden Esquire) of the third part the said William Duke of Devonshire granted unto the said William Currey and his heirs all that the patronage or right of nomination and presentation to the said new parish of Saint George Barrow (therein called the perpetual curacy of Saint George Barrow-in-Furness in the county palatine of Lancaster) with the appurtenances thereto belonging to hold the same unto the said William Currey and his heirs to the use of the said William Duke of Devonshire Walter Francis Duke of Buccleuch and Queensberry, Lord Frederick Charles Cavendish, Henry William Schneider and James Ramsden their heirs and assigns for ever. Upon trust nevertheless that they the said William Duke of Devonshire Walter Francis Duke of Buccleuch and Queensberry Lord Frederick Charles Cavendish Henry William Schneider and James Ramsden should from time to time and at all times thereafter as often as the office of incumbent of the said perpetual curacy of Sainf George Barrow-in-Furness should become vacant and within six mouths after the beginning of each such vacancy duly nominate or présent such qualified Clerk in Holy Orders to be the minister or incumbent thereof as should be elected or chosen by any three trustees for the time being of the indenture now in recital whether they should be the whole number of such trustees for the time being or the majority of such whole number and the indenture now in recital contained a power to appoint new trustees as therein mentioned and it was thereby declared that it should not be lawful for the said William Duke of Devonshire Walter Franci- Duke of Buccleuch and Queensberry Lord Frederick Charles Cavendish Henry William Schneider and James Ramsden their heirs and assigns nor for any of them nor for any future or other trustees or trustee (whether appointed as hereinbefore constituting thereout a new archdeaconry within | provided or howsoever otherwise) acting in the
