Expenses.

40. With regard to the expenses attending the purchase of any Savings Bank Annuity or Savings Bank Insurance, the following rules shall apply:

(1.) The purchaser shall provide at his own cost any certificate of birth or baptism, or other evidence of age which may be required

by the Postmaster-General.

(2.) In the case of a Savings Bank Insurance where the sum insured does not exceed £25, in the event of a purchaser submitting to a medical examination, he shall bear the expense of such examination.

(3.) In the case of a Savings Bank Insurance where the sum insured exceeds £25, the expense of the medical examination shall be

borne by the Postmaster-General.

(4.) Save as aforesaid, no fees or expenses, except such as are provided by the tables framed under the authority of the Government Annuities Act, 1882, shall be paid in respect of the purchase of any Savings Bank Annuity or Savings Bank Insurance, and a proposal for the purchase of any Savings Bank Annuity or Savings Bank Insurance, and all correspondence between the purchaser and the Postmaster-General arising out of such proposal, or in connection with any payment to be made either by the purchaser or by the Postmaster-General in respect of any Savings Bank Insurance or Annuity, shall be transmitted by post free of postage.

Annuities and Insurances purchased before. Regulations.

41. With regard to Savings Bank Annuities and Insurances granted before these Regulations came into force, the following provisions shall have effect :-

- (1.) All payments, whether to or by the Postmaster-General, in respect of such Annuities and Insurances, shall continue to be made in accordance with the Contracts relating to the same.
- (2.) The Regulations herein contained with regard to the purchase and payment of An-nuities and Insurances through the Post Office Savings Bank, and (subject to the provisons of such Contracts as aforesaid), all other Regulations herein contained shall apply to the Insurances and Annnities purchased before these Regulations came into force, so far as the same are applicable.

INFORMATION has been received from the Naval Commander-in-Chief on the East India station, of the existence of two reefs lying near the fairway of approach to Sawakin from the .north-eastward:-

1. A reef, on which the sea was seen to break from H.M.S. "Jumna," lies with Hind Kadám (Hinde Gedam) Island bearing S.E. ½ E., distant 10½ miles.

Position approximate, lat. 19° 27' N., long. 37° 43′ E.

2. A reef lying with Sawakin Harbour Entrance,

bearing W.S.W., distant 10 miles.

This reef is difficult to distinguish, and when first seen from H.M.S. "Jumna," was indicated only by discoloured water, but on a subsequent occasion the sea was observed to break slightly

Position approximate, lat. 19° 13' N., long.

37° 31½′ E. [The bearings are magnetic. Variation 4¾° Westerly in 1884.]
