THE following Address of the General Assembly of the Church of Scotland, having been transmitted by John Campbell, Earl of Aberdeen, to the Right Honourable Sir William Vernon Harcourt, one of Her Majesty's Principal Secretaries of State, has been by him presented to the Queen, which Address Her Majesty was pleased to receive very graciously:-

May it please your Majesty,

WE, Your Majesty's most loyal and dutiful subjects, the Ministers and Elders of the Church of Scotland now convened in General Assembly, beg most respectfully and gratefully to acknowledge Your Majesty's most gracious letter. It is with the highest satisfaction and pleasure that we again receive the assurance of Your Majesty's continued regard for the Church of Scotland, of Your confidence in her loyalty and attachment to Your Majesty's person, and of Your sympathy with the work in which she is engaged.

We feel greatly encouraged in this work by Your Majesty's gracious words, as well as by the many acts which manifest Your attachment to the National Church. We shall be animated thereby to renewed effort; and we hope, through the aid of God's grace, and by a due apprehension of our responsibility as Ministers of Christ, to prove ourselves faithful to our high calling and to fulfil Your Majesty's loving wish for the advancement of religion in the land, and for the promotion of the happiness of Your Majesty's subjects in Scot-

We receive with lively gratitude Your Majesty's munificent gift of two thousand pounds for the advancement of religion in the Highlands and Islands of Scotland. It will be our earnest endeavour to apply this sum in such a manner as will further the benevolent objects which Your Majesty has so warmly at heart.

It is most pleasing to us that Your Majesty has again seen meet to appoint the Right Honourable John Campbell, Earl of Aberdeen, to represent Your Royal Person in this General Assembly. Bearing a name which will long hold a place in the grateful recollection of the Church of Scotland, esteemed so highly for his personal virtues, and having experienced his unwearied courtesy and kindness when formerly filling this high office, we rejoice in his appointment and thank Your Majesty for it.
