THE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Act, 1878, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

- 1. The limits of the following Place which is declared by order of the Sub-Committee for the petty sessional division of Staincliffe West of the Local Authority for the West Riding of the county of York, dated the eighth day of July, one thousand eight hundred and eighty-four, to be a Place infected with foot-and-mouth disease (namely),—the farm called Arnford Farm, situate in the township of Hellifield, in the West Riding of the county of York, in the occupation of Richard and William Hargreaves,—are hereby extended so as to include the Place described in the Schedule to this Order, and the Place described in the Schedule to this Order is hereby declared to be a Place infected with foot-and-mouth disease.
- 2. This Order shall take effect from and immediately after the fifteenth day of July, one thousand eight hundred and eighty-four.

A Place around the farm called Arnford Farm, situate in the township of Hellifield, in the West Riding of the county of York, in the occupation of Richard and William Hargreaves, comprised within the following boundaries, that is to say, commencing at Cow Bridge, thence along Flatlane to Bend Gate (including the said lane), thence along the Marsden, Gisburn, and Long Preston-road (including the said road) to the point where Pan Beck runs under the said road, thence along Pan Beck to the river Ribble, and thence along the river Ribble to Cow Bridge aforesaid.

THE Board of Trade have received through the Secretary of State for Foreign Affairs, information to the effect that the Sanitary Authorities at Seville have decided that all vessels from England or France bound to Seville are to be submitted to a rigid examination at the Horcada, this examination being additional and subsequent to the quarantine at lazaretto decreed by the authorities at Madrid. Vessels for Seville are not permitted to pass San Lucar, as on arrival they are ordered to Vigo to undergo quarantine.

THE Board of Trade have received through the Secretary of State for the Colonies copy of the following Notice respecting quarantine, which has been issued by the Government of Malta:-His Excellency the Governor, having heard the opinion of the Board of Health, has been pleased to direct that the period of quarantine against ports in the Mediterranean infected with cholera be twenty-one days from the date of arrival in Malta.

For the present, Toulon and Marseilles are declared to be infected ports.

Arrivals from ports which impose less than twenty-one days quarantine against infected ports, shall be subjected to a complementary period of quarantine sufficient to make up the total period of quarantine to the established period of twentyone days.

Passengers leaving ports infected with cholcra after the date of the present notice will not be allowed to land in Malta.

Vessels on board of which cholera shall have. declared itself during the voyage will not be allowed to communicate with the port.

THE Board of Trade have received through the Secretary of State for Foreign Affairs the following Telegram from Her Majesty's Ambassador at Constantinople: -July 14th. -Both passenger and cargo ships from French Mediterranean ports, including Algerian and Tunisian ports, undergo ten days quarantine either at Smyrna, Beirout, or Tripoli, in Barbary, the days of the voyage are counted up to five days, if the vessel be free from cholera and carry a medical officer on board, but in any case the vessel must perform five full days quarantine at one of those three lazaret stations; passenger ships from Varna, Kustendjie, the Danube, and Odessa undergo five days quarantine at mouth of Bosphorus; passenger ships from Brindisi and Trieste undergo a similar quarantine at Dardanelles, the days of voyage are not counted; cargo ships from Brindisi and Odessa if without passengers will be allowed to go through the Straits in quarantine, and with Turkish health officers on board; cargo vessels without passengers from Black Sea ports and all Mediterranean ports except the French ports are allowed to go through the Straits without restriction.

THE Board of Trade have received through the Secretary of State for Foreign Affairs a copy of a Despatch, dated 8th instant, from Her Majesty's Vice - Consul at Nice, reporting as follows with reference to the outbreak of cholera at Toulon:

Vessels coming from Toulon, Marseilles, and La Seyne bound for Nice, Cannes, or Mentone are subjected to eight days quarantine in the open harbour of Villafranche-sur-Mer.

Passengers by rail from the infected districts bound for Nice have to undergo five days quarantine at the Var before entering Nicc.

On arrival at Mentone passengers as above are detained for five days at the Hotel de la Gare, close to the station.

At Cannes no quarantine has as yet been enforced for arrivals by rail. Passengers from Marseilles and Toulon have to undergo fumigation at the railway station on arrival.

On the Italian frontier a quarantine of five days is being strictly enforced.
