A T the Council Chamber, Whitehall, the 2nd day of August, 1884.

By Her Majesty's Most Honourable Privy Council.

THE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Act, 1878, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

- 1. The exposure for sale of any cattle, sheep, or swine in or at the fair intended to be held at Lyndhurst, in the county of Southampton, on or about the ninth day of August, one thousand eight hundred and eighty-four, is hereby prohibited.
- 2. The exposure for sale of any cattle, sheep, or swine in or at any other fair, or in or at any market, auction, sale-yard, sale, or exhibition held during the continuance of this Order within a distance of five miles from any part of the Footand-Mouth Disease Intected Place, described in the Schedule to this Order) declared by the Committee for the Division of Lymington and the New Forest, in the said county, is hereby prohibited.
- 3. If a head of cattle or a sheep or a pig is exposed for sale in or at any market, fair, auction, sale-yard, sale, or exhibition in contraventi n of this Order, the owner or consignee of each head of cattle, and of each sheep, or pig so exposed, and the person so exposing the same, and the auctioneer, if any, or other person conducting a sale of cattle, sheep, or swine at such market, fair, auction, saleyard, sale, or exhibition, and the purchaser thereat of any cattle, sheen, or swine so exposed in contravention of this Order, such purchaser knowing the animal to be exposed for sale in contravention as aforesaid, shall, each according to and in respect of his own acts and defaults, be deemed guilty of an offence against The Contagious Diseases (Animals) Act, 1878.
