THE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Act, 1878, and of every other power enabling them in this behalf, and under and in pursuance of The Swine-Fever (Infected Circles) Order of 1884 (in this Order referred to as the Circles Order), do direct and order, and it is hereby directed and ordered, as follows:

1. The Circles Order shall, from the dates mentioned in Article 2 of this Order, apply and extend to and be in force in the District mentioned in the Schedule to this Order, and shall continue to apply and extend to and be in force in that District until the Privy Council by further Special Order direct and order.

2.—(1.) The provisions of Article 5 (Power to Local Authority to make Regulations) of the Circles Order shall apply and extend to and be in force in such District from the date of this Order.

(2.) Except as aforesaid, the provisions of the Circles Order shall apply and extend to and be in force in such District from and immediately after the fourth day of October, one thousand eight hundred and eighty-four.

THE Board of Trade have received through "the Secretary of State for Foreign Affairs a Despatch from Her Majesty's Consul at Boulogne, reporting that a tax of one franc will be levied on each passenger landing or embarking at that port or Calais, to commence from the 1st instant, and will be received by the Chambers of Commerce - of Boulogne and Calais respectively, to assist them in raising the funds which may be necessary for the completion of the harbour works at those ports. It would appear that the tax on passengers between Boulogne and Folkestone and Calais and Dover will be collected by the South Eastern Railway and Lordon, Chatham, and Dover Railway Companies.

THE Board of Trade have received through the Secretary of State for Foreign Affairs a copy of a Despatch from Her Majesty's Consul at Genoa, from which the following is an extract,

This port and the shore of the whole "Circondario" of Genoa are officially declared infected with cholera, and foul bills of health are issued.

Vessels from this port and shore are subjected on arrival at all non-infected Italian ports to the treatment decreed by Decree No. 20 of the 2nd instant, namely, ten days quarantine if no sickness ...on board, and twenty-one days if otherwise.

Vessels from places infected with cholera and with foul bills of health shall, until further orders, be admitted to free pratique, provided no sickness has manifested itself on board during the journey.

THE Board of Trade have received through the Secretary of State for Foreign Affairs a copy of a Despatch from Her Majesty's Reprentative at Rome, transmitting a Notice issued by the Italian Government, of which the following is a translation:-

ORDINANCE OF MARITIME HEALTH, No. 25. In consequence of the outbreak of cholera in Genoa and adjacent communes; the Minister of the Interior, decrees:-

ART. 1. The preventive treatment ordered in Ordinance No. 20 of the 5th instant, shall be applied to ships from this day forth quitting the ports and landings comprised within the shores of the neighbourhood of Genoa.

ART. 2. Both on the above shores and on those mentioned in Ordinances Nos. 16, 22, and 24 of the 23rd August and 7th and 22nd September, respectively, vessels arriving from places declared foul on account of cholera shall, until new orders, receive free pratique if they have had no illness For the Minister, on the voyage.

5. Except at a passing place or a terminus, and except, as provided in Bye-law 5 made by the Board of Trade on the 6th day of September, 1884, no car shall be stopped at the intersection or junction of two or more streets or roads, nor within ten yards of a car on an adjoining line of

6. The driver of a car, on coming in sight of a vehicle standing or travelling on any part of the road so as not to leave sufficient space for the car to pass, shall sound his whistle as a warning to the person in charge of such vehicle, and that person shall, with reasonable despatch, cause such vehicle to be removed so as not to obstruct the

7. No person shall in any way wilfully impede or interfere with the traffic on the tramways, nor shall any driver or conductor needlessly cause interruption to the ordinary road traffic.

8. Every driver, conductor, or other person l

offending against any of these Bye-laws and Regulations shall be liable to a penalty not exceeding forty shillings for each offence, and not exceeding for any continuing offence ten shillings for every day during which the offence continues.
