(PORT OF LEITH.—APPROVAL OF LANDING-PLACE FOR FOREIGN ANIMALS.)

AT the Council Chamber, Whitehall, the 4th day of October, 1884.

By Her Majesty's Most Honourable Privy Council.

THE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Act, 1878, and of every other power enabling them in this behalf, do hereby approve of the following part of the Port of Leith as a Landing-Place for foreign animals not subject to slaughter or quarantine:

All that space in the parish of South Leith, in the county of Edinburgh, situated on the north side of the Albert Dock Basin, commencing at a point at the water's edge three hundred and forty-eight feet west of the East Quay of the said Basin, thence in a northerly direction for a distance of twelve feet bounded by high wooden gates, thence in an easterly direction for a distance of ninety-five feet six inches bounded by the side of the cattle sheds and a high wooden fence, thence in a northerly direction for a distance of eighty-one feet bounded by a high wooden fence, thence in a westerly direction for a distance of two hundred and eighty-three feet bounded by a high wooden fence, thence in a southerly direction for a distance of twenty-five feet bounded by a high wooden fence, thence in an easterly direction for a distance of one hundred and seventy-three feet six inches bounded by a high wooden fence and the side of the cattle sheds, thence in a southerly direction for a distance of twelve feet to the water's edge bounded by high wooden gates, and thence along the edge of the wall of the North Quay of the said Albert Dock Basin for a distance of twelve feet to the point first-mentioned, all which space is edged pink on the plan of the said Landing-Place deposited for the purposes of this Order at the Privy Council Office, a copy of which is deposited at the office of the Town Clerk of the burgh of Leith.

This Order shall take effect from and immediately after the thirteenth day of October, one thousand eight hundred and eighty-four.

(SWINE-FEVER.)

AT the Council Chamber, Whitehall, the 6th day of October, 1884.

By Her Majesty's Most Honourable Privy Council.

THE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Act, 1878, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

1. The limits of the following Place which is declared by order of the Local Authority for the borough of Peterborough, dated the twenty-sixth day of September, one thousand eight hundred and eighty-four, to be a Place infected with swine-fever (namely),—the pig-sty on premises situate in Christian-street otherwise St. Marks-road in the occupation of Mr. J. W. Buckle,—are hereby extended so as to include the Place described in the Schedule to this Order, and the Place described in the Schedule to this Order is hereby declared to be a Place infected with swine-fever.

2. This Order shall take effect from and immediately after the seventh day of October, one thousand eight hundred and eighty-four.

## SCHEDULE.

A Place comprising so much of the borough of Peterborough as lies within the following boundaries, that is to say, on the north Lincoln-road East, on the east and south Christian-street otherwise St. Marks-road, and on the west Lincoln-road; the said roads not being included in the Infected Place except Christian-street otherwise St. Marks-road.
