THE Board of Trade have received through the Sccretary of State for Foreign Affairs a copy of a Notice issued by the Austro-Hungarian Government of which the following is a translation, viz. :-

Circular of the Maritime Government to all the officers and functionaries in the Sanitary Harbour Service:

By the Ordinance of the 11th instant, issued by the Ministries of the Interior of Commerce and of Finance, contained in the Gazette of the Laws of the Empire, lettered L, No. 152, in concert with the Royal Government of Hungary, is prohibited the importation from Spain not only of rags and old ropes, but of old clothes, worn out linen, and second-hand bed clothes, in case these objects are destined to be made use of in commerce; the intention being to prevent all risk of the introduction of contagious diseases.

This Ordinance comes into force on the day upon which it reaches the Custom-house offices wh ch are concerned with sanitary harbour regu-

It any of the above mentioned articles are brought into Austrian ports by Austrian or foreign vessels, they must immediately be taken to the nearest maritime lazzaretto, and be reexported to the persons who sent them with the

shortest possible delay, and if at the close of this period of delay the articles still remain there, they must be destroyed.
