Cripplegate Vestry. (Alteration, Amendment, or Repeal of "The Parish of Saint Giles' Cripplegate Vestry Act, 1869;" Removal of Doubts as to Qualification and Election of Vestrymen; Application of Certain Provisions of "The Metropolis Local Management Act, 1855;" Alteration of Constitution of Vestry; Confirmation of Elections, Rates, Acts, Deeds, &c.; Incorporation and Amendment of Acts; and other Purposes.)

OTICE is hereby given, that application is intended to be made to Parliament in the

ensuing session for leave to bring in a Bill for all No. 25414.

or some of the following among other purposes,

that is to say: -

1. To remove and put an end to doubts which have arisen as to the true construction of certain of the provisions of "The Parish of Saint Giles" Cripplegate Vestry Act, 1869 (hereinafter referred to as "the Act of 1869").

2. To alter the qualification of vestrymen of the parish of Saint Giles Without Cripplegate, and to render it unnecessary for such vestrymen to be resident householders, or to be separately

rated.

3. To incorporate with, or apply to the purposes of the Bill, and either wholly or partially, and with or without alteration, modification, or amendment, all or some, one or more of the provisions of sections 1 to 30 of "The Metropolis Local Management Act, 1855," being the provisions of that Act with respect to the "Election of Vestries and Auditors in Parishes in Schedules (A) and (B)," and further to declare and enact that the provisions so to be incorporated or applied shall be deemed to have always applied to the election of vestries and qualification of vestrymen in the parish of Saint Giles Without Cripplegate, and to the acts and deeds of the vestry.

· 4. To alter the constitution of the vestry of the parish of Saint Giles Without Cripplegate, and to provide for the continuance for such time as the Bill may define of the members, or some of the members, of the present vestry as members of the

new vestry.

5. To confirm and declare valid all elections, rates, acts, deeds, matters, and things heretofore held, done, levied, executed, or omitted under or in pursuance of the powers and provisions of the Act of 1869, or purporting to have been held, done, levied, executed, or omitted under or in pursuance of the powers and provisions of the Act of 1869, and to repeal, alter, or amend such of the provisions of the Act of 1869 as it may be found necessary or deemed expedient to repeal, alter, or amend for any of the purposes of the Bill, or to enact other provisions in lieu thereof.

6. To define the powers, rights, duties, privileges, and authorities of the vestry of Saint Giles

Without Cripplegate.

7. To confer all rights and privileges necessary or expedient for or incidental to the purposes of the Bill, and to vary and extinguish all rights and privileges inconsistent with the purposes thereof.

8. To make provision for the payment out of the poor rates or other local rates of the parish of Saint Giles Without Cripplegate of the costs and expenses of and incidental to the preparation and

passing of the Bill.

9. To alter or amend, and, so far as may be necessary or expedient for any of the purposes of the Bill, to repeal all or some of the provisious of the public Acts 6 George II, chapter 21; 58 George III, chap. 69; 59 Geo. III, chap. 85, and I and 2 William IV, chap. 60, so far as the same relate to or affect the parish of Saint Giles Without Cripplegate, and the local and personal Acts 7 Geo. IV, chap. 54, the parish of St. Giles' Cripplegate Vestry Act, 1869, and any other Act relating to the parish of St. Giles Without Cripplegate.

Printed copies of the Bill will, on or before the 20th day of December, 1884, be deposited in the Private Bill Office of the House of Commons.
