1884. ORDINANCE OF MARITIME HEALTH NO. 34. ART. 1. The quarantine applied by Ordinance No. 21 of September 3rd last to vessels coming from the Spanish Mediterranean coasts is revoked, as regards vessels which left those coasts from the 25th October last, if furnished with a clean bill of health and without sickness on board, on arriving at the ports and roadsteads of the Italian continent. They shall therefore be admitted after medical inspection.

ART. 2. Until new orders, the prohibition of importation of rags, tatters, and other things laid down in the above ordinance shall remain in force. For the Minister,

THE Board of Trade have received through the Secretary of State for Foreign Affairs the following translation of a Notice as to quarantine issued by the Spanish Government, viz.:

## Circular.

A Royal Decree of this date having ordained the strict re-establishment on our frontier and in our ports of the precautions laid down by the sanitary laws, and in order that the intentions of the Government may be carried out by you with precision and energy throughout the whole extent of your district, according to the provisions of the said Royal Decree, this Central Department has seen fit to adopt the following regulations :—

1. All travellers proceeding from France by land shall undergo a strict quarantine of ten days in one of the lazarets on the French frontier, and their luggage shall be properly disinfected by means of ventilation and fumigation. Passengers subject only to the hygicnic measures laid down as regards port lazarets, in Regulation 5 of the Royal Decree of September 18, 1879, shall not be required to undergo fumigation.

2. The following suspected goods shall likewise be subject to strict disinfection, ventilation, and fumigation: clothes, hides, feathers, hair, flax, hemp, and paper proceeding from the manufactory as articles of trade and commerce; and these goods shall be detained only such time as shall be absolutely necessary for their disinfection.

3. Raw and packed hides, rags, and other goods mentioned in the foregoing paragraph, which do not come under the heading of goods prepared for various industries by the manufacture of raw

materials, shall be absolutely refused permission to enter the country across the said frontier.

4. Vessels from foul French ports shall undergo ten days strict quarantine at a foul lazaret, and vessels from the remaining ports of France which are regarded as under suspicion shall undergo seven days, all being subject to the regulations contained in cap. 9 of the Sanitary Law.

5. Vessels from any port of a foreign country whose quarantine or sanitary regulations have been less strict than those laid down by the Sanitary Law of Spain shall undergo three days of observation, according to Art. 36 of the said Law.

6. Animal or vegetable substances in a state of putrefaction shall not be admitted into any lazaret either in a port or on land. Should they be found in such a condition they are to be destroyed by fire.

7. Official and private correspondence shall be admitted forthwith, after due ventilation and fumigation. ALBERTO BOSCH,

The Minister of the Interior, on account of the complete cessation of cholera in the city of Salerno and its neighbourhood, decrees :

ART. 1. The quarantine imposed by Ordinance No. 27, of October 21st, for arrivals from the port of Salerno, is revoked for ships leaving that place from this date for Italian continental ports and arriving after a clean passage.

ART. 2. Arrivals at the port of Salerno will from this date undergo the same treatment as is applied at uninfected ports to ships coming from places where quarantine is now imposed in the Kingdom of Italy. For the Minister,
