Birmingham (Extension of Post Office). Certain lands, houses, buildings, and premises, situate in the parish and borough of Birmingham, in the county of Warwick, that is to say, certain houses or properties being Nos. 42, 43, and 44, in Paradise-street, and Nos. 12 and 13, in Swallow-street, in the said parish and borough, and which said lands, houses, buildings, and premises abut on the north to Paradise-street, and are bounded on the western side by property reputed to belong to William Barker, and the Council of the Queen's College, and on the southern side by Swallow-street, and on the eastern side by the Birmingham Head Post Office, all in the said parish and borough of Birmingham.

Bristol (Extension of Post Office).
Certain landss, houses, and buildings, situate in the parish of All Saints, in the city and county of Bristol (that is to say), certain lands, houses, and buildings, known as New Buildings and numbered, 3 in Small-street, and which are bounded on the north-east by Small-street, on the south-east by suction rooms and counting houses belonging to the London and South Western Bank Company (Limited), and now in the occupation of Messrs. W. H. Phillips and Company, the back portion of the Commercial Rooms, and the shop and premises belonging to Frederick Granger, and occupied by Messrs. Laverton and Company, both fronting Corn-street; on the south-west by counting houses and premises belonging to the Royal Insurance Company, and occupied by the Stock Exchange, Charles F. Henderson, Messrs. Jacques, Pease, and Jacques, and Henry Collins; on the north-west by the Bristol Head Post Office.

Newcastle-upon-Tyne (Extension of Post Office.) Certain lands, houses, and buildings situate in the parish of St. Nicholas, and parish or parochial chapelry of St. John's, in the city and county of Newcastle-upon-Tyne, or one of them, in the county of Northumberland, that is to say certain houses and properties being Nos. 16, 18, 20, 22, 24, 26, 28, 30, 32, and 34 in Westgate-road, within the said parishes, and which said houses and the land upon which the said houses and properties are erected are situate on the north-east side of Westgate-road, and are bounded on the south-west by the said Westgate-road; on the south-west by the said Westgate-road; on the south-east by premises in the occupation of Stephen Quin; on the north-east by the Newcastle-upon-Tyne Head Post Office; and on the north-west partly by a public highway, known as the Denton Chare, and partly by houses, shops and buildings abutting upon the said Denton Chare and numbered 29, 31, 33, 35, 37, 39, and 41.

And the said Act will empower the Postmaster-General to purchase by compulsion or agreement other lands and property, and to pull down and remove buildings and houses or some parts thereof, and to sell the materials thereof, and appropriate the sites, and to take and hold easements in or over land, and to erect and maintain offices and buildings and other conveniences on any of such lands. And it is proposed by the said Act to empower the Postmaster-General to stop up, divert, alter, or remove or appropriate, temporarily or permanently, streets, roads, ways, paths, or passages over by the side of or adjoining the premises so intended to be acquired as aforesaid, and particularly to stop up and appropriate the site of the street or public highway known as

Bull and Mouth-street, running between St. Martin's-le-Grand and King Edward-street, in the parishes of St. Anne and St. Agnes, and Christchurch, and also the public passage or footway runing between Knightrider-street and Carter-lane, and known as Bell-yard, in the parish of St. Gregory by St. Paul's, all in the city of London, and, if need be, to stop up, appropriate or divert any sewers or drains in or under the same respectively, and also to throw land into or add to any roads, ways, paths, streets, places, or passages.

To empower the Postmaster-General and any corporation, body, or person to enter into contracts and agreements with reference to the formation, diversion or alteration of streets and highways, and with reference to a sale, lease, or exchange of land, and to make money payments in respect thereof, and to sell, lease, or otherwise dispose of any lands now or which may hereafter

be vested in him.

The intended Act will confer all such other rights, powers, and privileges as may be necessary or convenient for the purposes aforesaid, and will vary and extinguish all existing powers, rights, and privileges in or over the lands intended to be taken under the powers of the Bill, or which would in any manner impede or interfere with any of its objects, and will confer, vary, or extinguish other rights and privileges.

To enable the Postmaster-General if he thinks fit to purchase so much of any house, building, or manufactory, or other hereditaments as he may require for any of the purposes of the intended Act, without being subjected to the liability imposed by the 92nd section of the Lands Clauses Consolidation Act, 1845

or of any other Act or Acts.

The Bill will, for the purposes aforesaid, so far as may be necessary, incorporate the Lands Clauses Consolidation Acts, 1845, 1860, and

On or before the 29th day of November instant, a plan and duplicate describing the situation of the said lands, houses, buildings and hereditaments so proposed to be taken as aforesaid, and a book of reference to the plan, with a copy of this notice as published in the London Gazette will be deposited for public inspection with the Clerk of the Peace for the city of London, at his office at the Sessions House, Old Bailey, in that city; with the Clerk of the Peace for the county of Middlesex, at his office at the Sessions House, Clerkenwell. in that county; with the Clerk of the Peace for the county of Gloucester, at his office at Gloucester, in that county; and with the Clerk of the Peace for the city and county of Bristol, at his offices at Bristol; with the Clerk of the Peace for the county of Northumberland, at his office at Newcastle-upon-Tyne, in that county; and with the Clerk of the Peace for the county of Warwick, at his office at Warwick, in that county; and that on or before the said 29th day of November a copy of so much of the said plan and book of reference as relates to each parish and extra-parochial place in which any lands to be taken or acquired compulsorily under the powers of the Bill are situate, together with a copy of this Notice as published in the London Gazette, will be deposited for public inspection as follows (that is to say): in the case of the parish of St. Mary, Whitechapel, with the Clerk of the Board of Works for the Whitechapel district at his office at 15, Great Alie-street, Whitechapel, and in the case of the parish of Hackney, with the clerk of the Board of Works for the Hackney District, at his office at the Town Hall, Hackney, E., and in the case of each other parish with the parish clerk thereof at his residence,
