to or necessary for the purposes aforesaid, and it will vary or extinguish all rights and privileges which would interfere with the objects thereof, and provide for the winding up and dissolution

of the Company.

The Bill will also, so far as may be necessary to effect the objects and purposes thereof, alter, amend, or repeal all or any of the powers and provisions of the Charing Cross and Waterloo Electric Railway Act, 1882, and all other Acts relating to the Company.

OTICE is hereby given, that application is intended to be made to Parliament in the ensuing Session for an Act to carry into effect the following, or some of the following, among other purposes, and to confer the following, or some of the following, among other powers (that

is to say):
