THE Board of Trade have received through the Secretary of State for Foreign Affairs a Despatch from Her Majesty's Consul at Callao reporting that it has been further decreed by the Peruvian Government that ships proceeding from places abroad where there are Peruvian Consuls to any port whatever of the Republic must be provided with bills of health countersigned by such Consuls, and that in cases where vessels leave these ports where no Peruvian Consuls exist, the said bills of health must be countersigned by the Consular officer of some other friendly nation.
