1. Sheep, goats, and swine brought from the port of Geestemünde, in the German Empire, shall not be landed in England or Wales or Scotland.

THE Board of Trade have received through the Secretary of State for Foreign Affairs a copy of a Royal Order and relative Ministerial Order in respect of quarantine in Belgium, which were published in the Belgian Moniteur of the 20th instant, and of which the following is a translation :--

ART. 1. Our Order of the 19th January, 1884, is revoked. In consequence, all measures of quarantine and prohibition as regards importation and transit in respect of cholera are withdrawn.

ART. 2. Our Minister of the Interior and Public Instruction, charged with the execution of the present Order, is authorised to prescribe measures of precaution the necessity of which may become apparent in respect of all arrivals from abroad, and to make such special arrangements as there may be occasion for adopting as regards the importation of rags by sea or land.

ART. 3. The present Order shall be in force from the day after its publication in the Moniteur. Given at Brussels, 18th February, 1885.

The Minister of the Interior and Public Instruction, having regard to Art. 2 of the Royal Order of the 18th February, 1885, orders :---

ART. 1. The importation of rags coming from Italy, France, Egypt, Spain, Algeria, and the Indies is only allowed on condition that each consignment is accompanied by a certificate of the local authority proving that these goods do not come from towns or districts which have been infected.

Consignments not accompanied by this document will only be admitted on the production of a certificate, duly legalized by the local authority, proving that the rags to which it relates have undergone preliminary disinfection.
