warehouse, at the expense of the parties interested, and under supervision of the police and Customs authorities.

ART. 2. New waste produced in the countries mentioned in Art. 1, and coming direct from spinning, weaving, or clothing mills, will be admitted on condition that its origin is proved by a written declaration on the part of the producer at the place from which it comes. This declaration must be correctly certified and legalized by the local authority or the Belgian Consul at the place from which it comes.

In the absence of this certificate, new waste

will be dealt with as coming under Art. 1.

ART. 3. The provisions of Arts. 1 and 2 will be applicable to rags in through transit, when such transit is to be effected otherwise than by rail direct.

ART. 4. Consignments of rags coming from countries other than those indicated in Art. 1 will not be relieved from the formalities mentioned in the present Order, except upon proof of their origin to the satisfaction of the Customs Administration.
