

powers vested in them under section 1 of the Act of the 30th March, 1885, respecting additional precautions to prevent the importation of Asiatic cholera into Denmark, do hereby order that quarantine shall be imposed in pursuance of the provisions of the above-named Act, with respect to ships arriving from, or that have been in communication on the voyage with ships coming from any Spanish Mediterranean ports.

Moreover, the Order of the Ministry of Justice, dated the 17th of September, 1884, prohibiting the importation into Denmark of the following articles in ships coming from or that have been in communication with any of the ports above referred to, still remains in force, viz. :—

Used linen, used wearing apparel, used bed clothes (provided the said articles do not belong to a passenger's private effects), rags, used wadding, wool, paper refuse, hair, and skins.

Her Majesty's Consul reports that the Act of the 30th March, 1885, referred to in this proclamation provides, together with certain measures to be adopted in the event of an outbreak of cholera on board, that any ship arriving from an infected port shall, on entering Danish waters, fly a yellow or green flag at the main-top until the Sanitary Authorities have visited the ship and have admitted her to free pratique.
