the Governing Body of the Queen's College, in the University of Oxford, did, at a General Meeting specially summoned for the purpose, unanimously make the following Statutes, altering some of the Statutes made by the Commissioners as is hereinafter set forth. And whereas it is provided by the aforesaid Act, clause 55, that Statutes so made shall be submitted to the Queen in Council, and proceeded on as is by the aforesaid Act provided.

"Now we the Provost and Scholars of the said College, being the Governing Body thereof, humbly submit the following Statutes to the Queen in Council, to be proceeded on as is in the aforesaid

Act provided :-

THE STATUTES.

" In Statute III:-

1. At the beginning of clause 4 to strike out the words, "No person shall be elected to an open Scholarship who shall have exceeded the age of eighteen years on the tenth day of October next preceding the day of election," and to substitute instead thereof the following words, "No person shall be eligible to an Open Scholarship whose age on the day of election shall exceed nineteen years."

2. At the beginning of clause 11 to strike out the words, "Every Scholarship shall be tenable from the tenth day of October next following the election of the Scholar until the expiration of two years from that date," and to substitute instead thereof the following words, "Every Scholarship shall be tenable for two years from the day of election or from such subsequent day, being not later than the tenth day of October next following the day of election, as the Provost and Fellows shall at the time of the election appoint.

In witness whereof we have hereto set our Common Seal this twenty-ninth day of June, one thousand eight hundred and eighty-five."

1. The Circles Order shall, from the dates mentioned in Article 2 of this Order, apply and extend to and be in force in the District mentioned in the Schedule to this Order, and shall continue to apply and extend to and be in force in that District until the Privy Council by further Special Order direct and order.

2.—(a.) The provisions of Article 5 (Power to Local Authority to make Regulations) of the Circles Order shall apply and extend to and be in force in such District from the date of this

Order.

(b.) Except as aforesaid, the provisions of the Circles Order shall apply and extend to and be in force in such District from and immediately after the thirteenth day of July, one thousand eight hundred and eighty-five.

Principal Secretary of State for Foreign Affairs, has received a Despatch from Her Majesty's Chargé d'Affaires in Peru, an extract of which is given below, transmitting a copy and translation of an Order issued by the Peruvian Government, under date of the 20th of May last, closing the Port of Salaverry to commerce.

Extract:-

"Further north, the Montoneros have repossessed themselves of Trujillo, the troops sent to defend that place on behalf of the Government being quite inadequate for the purpose. Government in consequence has had recourse to the expedient of port closing, and has issued an Order shutting up Salaverry.

I beg to inclose a copy of this Order, which runs as follows:—

Ministry of Finance and Commerce, Lima, May 20, 1885.

To suit fiscal interests let the trading port* of Salaverry be closed to commerce till the Government dispose otherwise.

Let this be communicated, registered, and published." (Signed) GALUP.
