By Her Majesty's Most Honourable Privy Council.

THE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Act, 1878, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows :

1. The Area described in the Schedule to this Order is hereby declared to be an Area infected with foot-and-mouth disease.

2. This Order shall take effect from and immediately after the twenty-sixth day of September, one thousand eight hundred and eighty-five.

SCHEDULE.

An Area comprising such portion of the parishes of Walsoken and Emneth, in the county of Norfolk, as lies within the following boundaries, that is to say, the Norwich-road from Wisbech Canal at Walsoken to Blackberry-lane on the north, a public-road leading from Oxburgh Hall to Emneth Church on the south, a lane called Lady's Drove leading from Walsoken Station to Emneth Church on the east, and the Wisbech Canal on the west.
