THE Board of Trade have received through the Secretary of State for Foreign Affairs a Despatch from Her Majesty's Consul-General at Constantinople, transmitting a copy of a circular issued by the Ottoman Board of Health, of which the following is a translation:—

Circular Telegram, addressed to Health Offices on the 4th November, 1885.

By decision of the Council, the quarantine on arrivals from the Mediterranean coasts of France and Italy, those of Sicily excepted, is reduced from 10 to 5 full days, to be undergone in one of the lazarets at Smyrna, Beyrout, Tripoli (Africa),

or Vallona. Arrivals from Spain, Algeria, Tunis, and Sicily remain as hitherto, subject to 10 full days. A visit from a medical officer is substituted for the quarantine of observation on arrival of passengers from Varna, Bourgas, Odessa, the ports of Roumania, Trieste, and Egypt. Arrivals from Gibraltar are also admitted to free pratique after a visit from the medical officer. These regulations commence from this date, except for ships now in quarantine which remain subject to the former regulations.

The Consul further states that the Order issued on the 8th August last, imposing quarantine on ships from French Mediterranean ports included ports in Algeria.

THE Board of Trade have received through the Secretary of State for Foreign Affairs a Despatch from Her Majesty's Consul-General at Constantinople transmitting a Circular Telegram issued by the Ottoman Board of Health, of which the following is a translation :—

CIRCULAR Telegram addressed to the Health Offices on the 8th November, 1885.

From to-day free pratique will be granted in our health ports to all vessels which have left the Italian or French Coast within fifteen days, and which have clean bills of health obtained on the voyage in an uninfected port. Vessels in this category actually in quarantine will have the benefit of this regulation. Vessels arriving from Spain, Algeria, Tunis, and Sicily are subject to the regulation in our circular of the 14th October.

Non-Existence of Rattray Shoal.

INFORMATION has been received from Staff Commander Tizard, H.M. Surveying-vessel "Triton," of an unsuccessful search made in October, 1885, for the doubtful Rattray Shoal, which is shown on the charts as lying in the fairway of entrance to the Firth of Forth, with May Isle High Lighthouse bearing W. $\frac{1}{4}$ N., distant $7\frac{1}{2}$ miles.

This search, coupled with the fact that the fishermen of the neighbourhood know nothing of it, is considered to prove its non-existence, and it has therefore been removed from the Admiralty Charts.
