Loughborough Local Board.

(Construction of Additional Waterworks; Extension of limits of supply to include part of Parish of Sheepshead; Power to take Brooks, Streams, and Waters; Compulsory purchase of Lands, &c.; Breaking up, &c., of Roads, Streets, &c.; Rates, Rents, and Charges; Provisions against waste, misuse, or contamination of Water; Agreements with Public Authorities, Companies, &c.; Further borrowing powers; Incorporation of part of Railways Clauses Consolidation Act, 1845; Amendment of Acts.)

NOTICE is hereby given, that application is intended to be made to Parliament in the ensuing Session, by or on behalf of the Local Board of Health for the District of Loughborough, in the county of Leicester, hereinafter called "the Local Board," for leave to bring in a Bill for effecting the purposes, or some of the purposes following, that is to say:—

To empower the Local Board to make and maintain, with all necessary approaches, embankments, roads, filtering-beds, wells, dams, sluices, culverts, mains, pipes, engines, and all works and conveniences necessary for the supply of water, the waterworks, and other works hereinafter mentioned, or some of them, or some part or parts thereof respectively, all in the county of Leicester (that is to say):—

- (a.) A Reservoir (No. 1) in the parishes of Whitwick and Sheepshead, or one of them, to be situate on a piece of land now belonging or reputed to belong to Everard March Phillipps de Lisle, Esq., containing 1 acre or thereabouts, and including the bed and banks of the stream known as Black Brook, by which it is intersected, and the northern side of which reservoir will cross the said brook at a point thereon about 630 yards measured along the course of the said stream, above the site of the embankment of the disused Charnwood Forest Canal Reservoir, in the parishes aforesaid, or one of them.
- (b.) A Reservoir (No. 2) in the parishes of Whitwick and Sheepshead, or one of them, to be situate on a piece of land now belonging or reputed to belong to Everard March Phillipps de Lisle, Esq., containing 1 acre or thereabouts, and including the bed and banks of the stream known as Black Brook, by which it is intersected, and the northern side of which reservoir will cross the said brook at a point thereon about 50 yards measured along the course of the said stream, above the site of the embankment of the disused Charnwood Forest Canal Reservoir, in the said parishes, or one of them.
- (c.) A conduit or line of pipes (No. 1) commencing in the parishes of Whitwick and Sheepshead aforesaid, or one of them, in and out of the intended reservoir (No. 1) above described, and terminating in or near the centre of the north-west side of the existing reservoir of the Local Board in the parish of

Loughborough, which conduit or line of pipes (No. 1) will be made, or pass from, in, through, or into the parishes, townships, and places following, that is to say: Whitwick, Sheepshead, Knight Thorpe, and Loughborough, or some of them.

- (d.) A conduit or line of pipes (No. 2) in the parishes of Whitwick and Sheepshead aforesaid, or one of them, commencing in and out of the intended reservoir (No. 2) above described, running thence westwardly for a distance of about 10 yards, and terminating by a junction with the intended conduit or line of pipes (No. 1).
- (e.) A conduit or line of pipes (No. 3) wholly in the parish of Loughborough, commencing by a junction with the intended conduit or line of pipes (No. 1), at a distance of about 50 feet north of its termination as above described, and terminating in the filter-beds of the Local Board lying to the north-east of their reservoir above-mentioned.
- (f.) A conduit or line of pipes (No. 4) wholly in the parish of Loughborough, commencing in and out of the intended conduit or line of pipes (No. 3) at or near the south-western corner of the filter-beds aforesaid, and terminating by a junction with the leading main of the Local Board at a point about 30 yards from its commencement in the filter-beds aforesaid.

To extend the limits of supply of the Local Board, so as to include so much of the parish of Sheepshead, in the county of Leicester, as lies to the northward of the Old Charnwood Forest Canal, or some portion or portions of that part of the said parish.

To enable the Local Board to collect, impound, take, use, divert, and appropriate, for the purposes of their Undertaking, all such streams and waters as will or may be intercepted by the proposed new works, or as may be found in, upon, or under any lands for the time being belonging to the Local Board, or which they may acquire under the Bill, or over, or in respect of which they have or may acquire easements, and especially the brook or stream in the parishes of Whitwick and Sheepshead, both in the county of Leicester, known as Black Brook, and the tributaries thereof, including Charley Brook, Dry Brook, and Hermitage Brook, the waters of which flow directly or derivatively into the River Soar, the Soar Navigation, the River Trent, the Trent Navigation, and the River Humber, and thence into the sea.

To empower the Local Board, for the purposes of the intended works and Act, to purchase or acquire by compulsion or agreement, or to take on lease any lands, houses, or buildings in the townships, parishes, and county aforesaid, and any rights, or easements in, over, or connected with any lands, houses, or buildings in the said townships, parishes, and county, and to sell, demise, or let lands, houses, and buildings.

To empower the Local Board to deviate in the construction of the intended works laterally and vertically, to the extent to be shown on the plans and sections to be deposited as hereinafter mentioned, or to be defined in the intended Act.

To authorise the Local Board to lay down, maintain, alter, and renew mains, pipes, culverts, and other waterworks in, through, along, under, across, and over public highways, streets, roads, streams, paths, and railways, and for the purposes of the intended Act, to break up, cross, alter, divert, stop up (either temporarily or permanently), and interfere with any roads, streets, highways, footpaths, bridges, canals, towing paths, railways, tramways, sewers, drains,
