Morecambe Tramways.

(Incorporation of Company; Power to Construct Tramways from Morecambe to Heysham ; Tolls, Rates, and Duties; Widening of Roads; Compulsory Purchase of Lands; Incorporation and Amendment of Acts, and other purposes.) OTICE is hereby given, that application is intended to be made to Parliament in the ensuing Session for leave to bring in a Bill for all or some of the following purposes (that is to **a**ny):

1. To Incorporate a Company and to enable it to make, form, lay down and maintain the several Tramways hereinafter described, or some or one of them, with all necessary and proper rails, plates, sleepers, works and conveniences (that is to say) :-

Tramway No. 1 commencing in the Crescent, Morecambe, at a point 1 chain or thereabouts east of the centre of the New Pier and opposite to the Pier Hotel, and passing in a south-westerly direction along the Crescent and the New Promenade, and terminating in that Promenade at its junction with Bold-street.

Tramway No. 1 will be a single line except between the following places, where it will be a double line, viz. :-

- (a) For a distance of 1 furlong 7 chains from its commencement.
- (b) For a distance of 3 chains southwards, of a point 2.65 chains south-west of the westernmost gate of the Midland Hotel.
- (c) For a distance of 3 chains southwards, of a point 3 chains north-east of Regent-road.
- (d) Between points respectively 1 chain and 4 chains of its termination.

Tramway No. 2 commencing at the termination of Tramway No. 1 in the New Promenade, and passing thence into and along the Sandylandslane, the Cross-lane, the Over Town-lane, and the Longlands-lane, and terminating at the southerly junction of that lane with Over Townlane.

 (e) In Over Town-lane for a distance of 3

Tramway No. 2.--(1) In Sandylands-lane on the north-west side between points respectively I chain and 4.50 chains from its commencement. (2) In Sandylands-lane on the north-west side between points respectively 6 chains and 1.50 chains north-east of the Cumberland View Inn.

(3) In Sandylands-lane on both sides for a distance of 3 chains southward of a point 1.50 chains north-east of the Cumberland View Inn.

(4) In Sandylands-laneon the north-west side from a point 1.50 chains south-west of the Cumberland View Inn to Cross-lane.

(5) In Cross-lane on the east side from Sandylands-lane to a point 1 chain north of the Lodge of the house occupied by Bartholomew Bottomley.
