

3. To revise, or abolish, the tolls, rates, and duties leviable under the Newlyn Pier and Harbour Order, 1884, and to empower the Commissioners to levy other tolls, rates, and duties in lieu of, or in addition to, the same; also to levy tolls, rates, and duties upon or in respect of the use of the extended harbour, or of the pier, works, and conveniences authorized by the proposed Order, and from time to time to vary the same, and to confer, vary, or extinguish exemptions from the payment of such tolls, rates, and duties, and to let on lease or otherwise, any such tolls, rates, and duties.

4. To reduce the number of Commissioners and to alter the day of election, and to make other provisions relative to the constitution and election of the Commissioners.

5. To confer on the Commissioners any rights, powers, and privileges necessary or proper for enabling them to carry the said Order into execution, to vary and extinguish all rights, powers, and privileges inconsistent with, or which would in any manner interfere with, the execution of the Order, and to confer other rights, powers, and privileges.

6. To incorporate with the said Order the whole, or any part, of the Newlyn Pier and Harbour Order, 1884, the Lands Clauses Consolidation Acts, 1845, 1860, and 1869, as amended by any later Acts; the Commissioners Clauses Consolidation Act, 1847; the Harbours, Docks, and Piers Clauses Act, 1847; the General Pier and Harbour Act, 1861; and the General Pier and Harbour Act, 1861, Amendment Act, or some of them; and to amend, extend, or apply all or some of the provisions of the Newlyn Pier and Harbour Order, 1884, and all or some of the foregoing Acts.

And notice is hereby further given, that on or before the 30th day of November, 1885, plans and sections of the proposed pier, harbour, and works, and also a copy of this notice as published in the London Gazette, will be deposited with the Clerk of the Peace for the county of Cornwall, at his office at Bodmin, in the said county, and at the Custom-house at Penzance, in the said county, and at the offices of the Board of Trade, Whitehall, London.

Frith Hill, Godalming, and Farncombe Water.

(Application to the Board of Trade under the Gas and Waterworks Facilities Act, 1870, for a Provisional Order for Additional Waterworks and to extend the limits of Supply; Power to levy Rates; Power to raise additional Capital; Amendment of Order; and other purposes.)

NOTICE is hereby given that the Frith Hill, Godalming, and Farncombe Water Company, Limited (hereinafter referred to as "the Company"), intend to apply to the Board of Trade, pursuant to the Gas and Waterworks

Facilities Act, 1870, for a Provisional Order to be confirmed by Parliament in the ensuing Session for the following purposes, that is to say:—

1. To authorise and empower the Company, wholly in the parish of Godalming, in the county of Surrey, to construct and maintain the following works, that is to say:—

(1.) A reservoir and pumping station, to be constructed on a piece of land one acre or thereabouts in extent, situate on the southern side of Catteshall-lane at or near the eastern end of Spring-place, now belonging to the Company, but lately belonging to the trustees of Mrs. Eliza Marshall, and bounded on the north by Catteshall-lane, and on the east, south, and west by other lands belonging to the said trustees.

(2.) A water tower, to be constructed on a piece of land about two roods in extent situate at Crownpits, in the parish of Godalming, bounded on the north and east by land belonging to the Trustees of Mrs. Eliza Marshall, on the south partly by the allotment ground the property of Mr. John Cates Collier, and partly by a strip of land intended as a roadway hereinafter described, and on the west by land belonging to Mr. Roderick B. Shearburn, and also an approach road on a strip of land about 10 perches in extent situate at Crownpits, in the parish of Godalming, intended as a roadway leading from the high road from Godalming to Hascombe to the piece of land the site of the water-tower before described.

(3.) All such cuts, adits, culverts, drains, sluices, wells, reservoirs, tanks, embankments, dams, filter-beds, mains, pipes, pumps, engines, machinery, apparatus, approaches, works, appliances, and conveniences in connection with the said works, and as may be expedient for the taking, collecting, impounding, and distributing of the waters hereinafter referred to.

2. To authorise the Company to take, divert, collect, impound, and appropriate for the purposes of their Undertaking, all such springs, streams and waters as will or may be intercepted by the proposed works, or as may be found on, in, or under any lands for the time being belonging to the Company, or over, or in respect of which they have any easements or which are within the limits of deviation shown on the deposited plans hereinafter mentioned, which waters, or some of them, now flow by means of a by-pass or ditch into the River Wey Navigation.

3. To constitute the said intended works for all purposes part of the Undertaking of the Company.

4. To enable the Company to deviate from the lines and levels shown on the deposited plans and sections to any extent defined in the Order.

5. To enable the Company to acquire by agreement, and to hold lands, easements, water, and property for the purposes of the Order and of their Undertaking.

6. To extend the existing limits of supply of the Company, as defined by the Frith Hill, Godalming and Farncombe Water Order, 1878 (hereinafter referred to as "the Order of 1878") so as to include therein the following townships, parishes, and places in the county of Surrey, that is to say:—Witley, Hambledon, Hascombe, Compton, Puttenham, Peperharow, Elstead, Shalford, and Bramley, and to extend and apply all or some of the powers and provisions of the said Order of 1878 to, and to enable the Company to exercise such powers and all or some of the
