being the fields numbered 411, 505, 506, 507, 508, 509, in the parish of Llangeinor, and 135 in the parish of Llandyfodwg, in the Ordnance Survey Map (scale 1-2500) for the said parishes, and bounded as follows: On the north, south, and east by land of the said Mrs. Caroline Ann Blandy Jenkins, and on the west by the Ogmore Valley Branch of the Great Western Railway; and (3) all those pieces of land situate at Llest, in the parishes of Llangeinor and Bettws, in the said county of Glamorgan, belonging, or reputed to belong, to Henry Lewis, Esq., and Christopher Rice Mansel Talbot, Esq., and in the respective occupations of the Llest Coal Company, Thomas Thomas, of Llest Colliery, haulier, and John Crook, of Cefn Gelli Farm, and containing 5a. 0r. 13p., being the fields Nos. 441 in the parish of Llangeinor, and 269 in the parish of Bettws, in the Ordnance Survey Map (scale 1-2500) in the said parishes, and bounded as follows: On the north and south by land of the said Henry Lewis; on the west by land of the said Christopher Rice Mansel Talbot; and on the east by the Garw Branch of the Great Western Railway.

12. To empower the Company upon the said pieces of land hereinbefore particularly described to manufacture and store gas, and to manufacture, utilise, and convert the residual products arising or resulting from the manufacture of gas and the several matters and things producible from such residual products, and to empower the Company to deal in, sell, and dispose of gas, coal, coke, lime, peat, oil, tar, chemicals, and other such residual and manufactured products, and to carry on the business usually carried on by companies or persons dealing in any of the matters and things aforesaid, and to manufacture, purchase, hire, and .supply gas meters, fittings, stoves, engines, or other apparatus.

other apparatus. 13. To empower the Company to purchase and take by compulsion or agreement, and to take leases of and to hold lands, houses, springs streams, waters, easoments, and rights of water and other rights and easements and other hereditaments in the several parishes and townships aforesaid, or elsewhere within their limits of gas or water supply for the purposes of their works, or of the Bill, and to sell and dispose of, or to let on lease from time to time, any land, houses, or other property of the Company, and to vary or extinguish any rights or privileges connected with any such lands, houses, springs, streams, waters, and other hereditaments.

waters, and other hereditaments. 14. To empower the Company to open, break up, cross, divert, raise, lower, alter, stop up, remove, or otherwise interfere with, whether temporarily or permanently, all such turnpike and other roads, highways, streets, footpaths, gas, water, and other pipes, sewers, canals, navigations, rivers, streams, bridges, railways and tramways, telegraphic and telephonic pipes, wires, and apparatus, and other works within the parishes and townships or hamlets aforesaid, or any of them, as it may be necessary or convenient to open, break up, cross, divert, raise, lower, alter, or stop up, remove or otherwise interfere with for the purposes of laying down pipes, culverts, and other works for the supply of water and gas, and for other purposes of the Company or of the Bill. 15. To empower the Company to demand and

15. To empower the Company to demand and take, and recover rates, rents, and charges, differential or otherwise, for the supply of gas and water, and for the sale, hire, or supply of gas and water meters, gas engines, gas stoves, fittings and apparatus, and to confer, vary, or extinguish exemptions from the payment of any such rates, rents, and charges.

16. To empower the Company to take, hold, and use patent rights, or licenses, or authorities under letters patent, for the use of inventions relative to the manufacture, conversion, utilisa-, tion, or distribution of gas, and of such materials and residual products as aforesaid, and for the filtering and purification of water, or otherwise, in connection with the supply of water.

17. To empower the Company to supply water by meter, and to sell, deal in, or supply water meters, fittings, and other apparatus, or to let water meters on hire.

18. To make special provision for the protection of the waterworks, property, and water supply of the Company, and for defining and regulating such supply, and for the prevention of frauds on the Company, and for preventing the pollution of the springs, streams, and gathering grounds, and sources of water supply of the Company, and for preventing the fouling, waste, abstraction, misuse, or unauthorised use of the water of the Company, and for making regulations with respect to such matters, and for imposing penalties for the breach of such rules and regulations, or of any of the provisions of the Bill.

19. To enter into and carry into effect contracts and arrangements for the supply of water and gas with any Local Board, Urban or Rural Sanitary Authority, or other local authority, and the trustees of any turnpike or other road, or any Highway Board, or surveyors of highways, and any Railway Company, and any other companies, bodies, or persons, and to vary, suspend, or rescind any such contract or arrangement, and to enter into and carry into effect other contracts or arrangements in lieu thereof, or in addition thereto, and to confer all necessary powers in that behalf upon all such authorities, boards, trustees, surveyors, companies, bodies, and persons.

20. To empower the Company on the one hand, and the Ogmore Gas and Water Company, Limited, on the other hand, to enter into and carry into effect any agreement for the purchase of that Company's undertaking by the Company, and to maintain the same, and to provide for the distribution of the purchase money amongst the members, and the dissolution and winding up of the said Limited Company.

21. The Bill may or will repeal, vary, or amend so much of the Llynvi Valley Gas Act, 1868, as authorises or empowers the Llynvi Valley Gas Company to supply gas within the Company's said intended limits of gas supply, or some part thereof, and so much of the Bridgend (Glamorganshire) Gas and Water Act, 1869, as empowers the Bridgend Gas and Water Company to supply water within the Company's said intended limits of water supply, or any part thereof.

of water supply, or any part thereof. 22. The Bill will repeal, extinguish, vary, or modify all existing powers, rights, privileges, and exemptions which may or can in any way impede or interfere with the carrying out of the intended objects, and will confer, vary, or extinguish other powers, rights, privileges, and exemptions.

23. Notice is hereby also given, that on or before the 30th day of November instant, duplicate plans and sections of the intended waterworks, showing the lines, situations, and levels thereof, such plans, showing the lands intended to be taken compulsorily for the same, and duplicate plans of the lands intended to be taken compulsorily for the intended Gas Works, with a book of reference to the said plans respectively, and a copy of this Notice, as published in the London Gazette, will be deposited for public inspection with the Clerk of the Peace for the
