

exclusive benefit and convenience of the County Lunatic Asylum at Whittingham.

To provide for the payment out of the General County Rate or any rate charged upon the county under the provisions of the Lunatic Asylums Act, 1853, or any other Act relating to lunatic asylums, of the expenses of making and maintaining the intended railway or tramway, and to mortgage and charge the said rates respectively for the purpose.

To make provisions as to the cost of constructing the said approach road, and to authorise the justices to raise and apply any moneys for the purpose, and to borrow money on the credit of the County Bridge Rate.

To provide that the said approach road shall, when completed, be maintained and repaired by the Leyland Hundred Highway Board, and be deemed to be a part of a main road.

To incorporate with the intended Act, subject to certain exceptions, the provisions of the Lands Clauses Consolidation Acts, 1845-1860, and 1869, and the Railways Clauses Consolidation Act, 1845, with respect to the temporary occupation of lands.

To amend, extend, vary, or repeal some or any of the provisions of the "Penwortham Bridge Act, 1885."

Duplicate plans and sections describing the line, situation, and level of the proposed road, and railway or tramway showing the lands, houses, and other property in or through which the works will be made, or which may be taken under the powers of the intended Act, together with a Book of Reference to such plans, and a copy of this Notice as published in the "London Gazette," and an Ordnance Map showing the line of railway or tramway delineated thereon, will on or before the 30th day of November instant, be deposited for public inspection with the Clerk of the Peace for the County Palatine of Lancaster, at the county offices Fishergate Hill, Preston, and that on or before the same 30th day of November a copy of so much of the said plans, sections and Book of Reference as relate to the several parishes or extra-parochial places in or through which the said intended works are proposed to be made or maintained, and a copy of this Notice as published in the "London Gazette" will also be deposited for public inspection with the Parish Clerk of each such parish at his residence, and in the case of an extra-parochial place, with the Parish Clerk of some adjoining parish at his residence.

Printed copies of the intended Act will, on or before the 21st day of December next, be deposited in the Private Bill Office of the House of Commons.

Salford Corporation.

(Power to Corporation to Subscribe to and Hold Shares in the Capital and to Appoint Directors of the Manchester Ship Canal Company; Increase of Number of Directors of that Company; Consequent Alterations in Manchester Ship Canal Act, 1885; Purchase of Waste Lands of the Duchy of Lancaster within the Borough; Borrowing Powers; Consolidation of Debts; Creation and issue of Corporation Stock, with usual powers; Levying of Rates; Repeal and Amendment of Acts.)

NOTICE is hereby given, that the Mayor, Aldermen, and Burgesses of the borough of Salford (in this notice referred to as "the Cor-

poration") intend to apply to Parliament in the ensuing Session for leave to bring in a Bill for the following, or some of the following, among other purposes, that is to say:—

1. To authorise and empower the Corporation to contribute towards the funds of the Manchester Ship Canal Company (hereinafter referred to as "the Company") or to subscribe towards the capital of the Company and to take and hold shares therein, either ordinary or preference, or both, and stock, and to nominate and appoint one or more directors of the Company, who may hold office without being qualified by the possession of shares in the capital of the Company, and to provide for and enable them to receive remuneration for their services without thereby disqualifying themselves from acting as members of the Council, and if thought fit to increase the number of the directors of the Company, and to provide for the representation of and the voting by the Corporation at meetings of the Company, and to alter and amend the Manchester Ship Canal Act, 1885, accordingly.

2. To empower the Corporation on the one hand and the Company on the other hand to enter into and fulfil agreements for and in relation to all or any of the purposes in the last paragraph mentioned, and to confirm any such agreement as may have been or which during the progress of the Bill may be entered into.

3. To authorise and empower the Corporation to purchase by agreement with the Duchy of Lancaster all or any of the waste and uncovered lands belonging to the said Duchy, and to enter into and fulfil contracts and agreements for and in relation to any such purchase, and to confirm any such agreement already or during the progress of the Bill to be made.

4. To extend the borrowing powers of the Corporation, and to enable them for all or any the purposes of the Bill to apply their corporate funds and any moneys they are already authorised to borrow, and to borrow further moneys by mortgage, annuities, or debentures, or by the creation and issue of stock, and to charge the moneys so borrowed or to be borrowed on all or any of the following securities, that is to say: The borough fund, borough rate, lands, tenements, hereditaments, undertakings, tolls, district and other rates, rents, and revenues of the Corporation, whether as a municipal, sanitary, or other authority, and to alter the present mode of charging moneys borrowed, and to make further provisions with respect to the mode of paying off moneys now owing or to be borrowed by the Corporation, and to levy such rates as may be requisite for the purposes aforesaid.

5. To authorise or provide for the consolidation and for the conversion into stock by agreement of all or any of the debts and monetary obligations of the Corporation, whether already or hereafter authorised to be created or contracted under the powers of any Act of Parliament, or the order of any department of the State, and for those purposes to enable them to create stock, terminable or perpetual, upon and subject to such terms as may be contained in the Bill or sanctioned by Parliament, and charged upon all or any of the before-mentioned securities.

6. To empower the Corporation to enter into and fulfil contracts and agreements with the Bank of England or any other bank, companies, or persons for and in relation to the issue and transfer of and payment of interest upon the said stock, and the keeping at such bank or elsewhere of the books of accounts, registers, and other documents relating thereto.
