tolls, rates, or charges arising from or in connection with such traffic, and to confirm, sanction, and give effect to any agreements already made or to be hereafter made between the Company or the said Railway Companies, or any of them on the one hand, and the said Steam Packet Companies and such other Companies, or persons, owners, or proprietors or charterers, or any or either of them on the other hand, in relation to any of the matters aforesaid.

To enable the Sutton and Willoughby Railway Company (in this notice called "the Company") to make and maintain the railway and works hereinafter mentioned, or some part or parts thereof, all in the Parts of Lindsey, in the county of Lincoln, with all necessary and convenient covered ways, rails, sidings, junctions, turntables, stations, approaches, roads, yards, walls, and other works, buildings, and con-
