thence proceeding in a northerly direction for a distance of 1,122 yards or thereabouts, and terminating at or near the junction of North-street, East-street, and West-street,

in the village of Prittlewell.

(2.) A road or street, commencing by a junction with the road or street, in the town of Southend, called or known as Miltonstreet, at a point 213 yards or thereabouts from its southern extremity, thence proceeding in a westerly direction for a distance of 213 yards or thereabouts, and terminating by a junction with the intended road or street (1.) above described at a point 220 yards or thereabouts from the commencement thereof as above described.

6. To enable the Local Board to purchase and take by compulsion or otherwise, lands, houses, and hereditaments for all or any of the purposes aforesaid, or other the purposes of the Bill, and to vary or extinguish any rights or privileges connected with any such lands, houses, and

hereditaments.

7. To empower the Local Board, notwithstanding Section 92 of "The Lands Clauses Consolidation Act, 1845," to purchase part only of any lands or buildings instead of purchasing, and without being liable or compellable to purchase, any greater portion or the whole thereof.

8. To enable the Local Board from time to time to sell or exchange any lands acquired by them under the Bill, and for the time being belonging to them, and to lay out the same for building purposes, and to grant building or other leases thereof, in such manner and upon such terms and conditions, pecuniary or otherwise, and for such period or periods as the Local Board may think fit, or as may be prescribed by the Bill, to accept the surrender of any lease of any lands or buildings, and to sell and dispose of any rent reserved, or agreed to be reserved, for any such lands, and the reversion and inheritance thereof, either absolutely or subject to such conditions as they think fit, and to make provision for the application of any purchase money, or other moneys which may be received by the Local Board, upon or in connection with

any such sale, exchange, or lease.
9. To authorise the Local Board to make and maintain in the parishes and places mentioned in this Notice, and every or any of them in connection with the intended works to be authorised by the Bill, or any or either of them, all necessary and convenient approaches, roads, ways, sewers, drains, mains, pipes, works, and conveniences, and to break up, alter, divert or stop up, either temporarily or permanently, any turnpike or other roads, streets, highways, footpaths, streams, watercourses, sewers, drains, pipes, railways, and tramways, within all or any of the said parishes and places which it may be necessary or convenient to break up, alter, divert, or stop up, for the purposes of the intended works or of the Bill; and to provide for the stopping up and discontinuance and the extinguishment of all rights of way over, and the appropriation to, the purposes of the Local Board of all roads and footpaths situate and lying within the limits of the lands purchased or acquired by them under the powers of the Bill; and in connection with the intended works, or any or either of them, and as part of such works, and within the parishes and places before mentioned, or any of them, to make and maintain junctions and communications with any existing streets or roads which may be altered or interfered with, by, or be contiguous to, the intended works or any or either of them, and to alter the line or levels of any streets, roads, or ways for the purpose of

connecting the same with the intended works, or any or either of them.

10. To empower the Local Board to deviate laterally from the lines of the intended works within the limits shown upon the plans to be deposited as hereinafter mentioned, and to deviate vertically from the levels of those works shown upon the sections hereinafter mentioned to such extent as may be authorised by the Bill.

11. To authorise and require the Great Eastern. Railway Company to abandon and relinquish the making of so much of the Railway No. 4 authorised by the Great Eastern Railway (General Powers) Act, 1883, as is situate and lies between the point 8 miles 1 furlong, as shown on the. deposited plans of that authorised railway, and the termination thereof, and to terminate the said authorised railway at the said point 8 miles 1 furlong, which portion of railway so to be abandoned is wholly situate in the said parish of Prittlewell, and to release the Great Eastern Railway Company from all penalties and obligations for the non-completion of the said portion of railway, and to declare null and void all contracts, agreements, and arrangements entered into by or on behalf of the Great Eastern Railway Company with reference thereto or to the purchase of lands and property for the same, and also to provide that the powers conferred on the Great Eastern Railway Company by the said last-. mentioned Act for the purchase, by compulsion, or agreement, of lands, shall not be exercised over or with respect to the lands numbered on the said deposited plans 37 and 38, in the said parish of Prittlewell, or such portions thereof respectively as shall be prescribed by the Bill, and, so far as may be necessary, to alter, amend, and repeal the provisions of the said Great Eastern Railway (General Powers) Act, 1883.

12. To enable the Local Board to apply to the purposes of the Bill any funds, moneys, tolls, rates, or revenues now belonging to them, or which they are now authorised to raise, levy, or receive, or which may come into their possession in exercise of the powers from time to time conferred upon them, and to enlarge the borrowing powers of the Local Board, and to authorise them to raise additional funds for all or any of the purposes of the Bill, or other purposes of the Local Board, by borrowing on the security of the District Fund and General District Rate, and all or any of the tolls, dues, and rates now authorised to be levied by, and of the funds, works and property now vested in them, and of the tolls, rates, dues, rents, and charges, and other revenues and property to be levied, created by, or to arise, and of the works to be executed under the powers of the Bill, by mortgage, or bond, or debenture stock, or by way of annuity, or otherwise, and to empower the Local Board to borrow any moneys which by the Bill they may be authorised to borrow, under the powers and subject to the provisions of "The Local Loans Act, 1875," by debentures, debenture stock, or annuity certificates, or partly in one way and partly in another, and to declare the funds, rates, securities, works and property on which any moneys so borrowed shall be charged, and to provide for the repayment thereof by means of

sinking funds or otherwise. 13. To confer upon the Local Board all powers, rights, authorities, and privileges which are or may become necessary for carrying the powers of the Bill into execution; to vary and extinguish, all rights and privileges inconsistent with or which would in any manner impede or interfere therewith, and to confer other rights and privileges.

14. To incorporate with the Bill, or to re-enact.
