with such variations, modifications, and exceptions as may be thought expedient, all or some of the provisions of, amongst other Acts, "The Lands Clauses Consolidation Acts, 1845, 1860, and 1869," "The Harbours, Docks, and Piers Clauses Act, 1847," and also such parts of "The Railways Clauses Consolidation Act, 1845," relating to roads and the temporary occupation of lands, and other matters, as may be deemed expedient, and to exempt the Local Board and their works and Undertakings under the Bill from some of the provisions of the above-mentioned
