(Dissolution of the Solihull Gas Company Limited; Incorporation of New Company; Additional Capital; Borrowing Powers; Limits of Gas Supply; Purchase of Lands; Manufacture and Storage of Gas on certain lands; Purchase of Gas in bulk; Power to deal in Coal Residuals; Gas Fittings; and to levy Rates, Rents, and Charges; Agreements with Sanitary Autho-rities and others; Power to acquire Patent Rights; Laying Down and Renewal of Gas Mains, Pipes, and Apparatus; Amendment and Incorporation of Acts.)

OTICE is hereby given, that application is intended to be made to Parliament in the ensuing session by the Solihull Gas Company Limited (hereinafter referred to as the Limited Company), for leave to bring in a Bill for an Act for all or some of the following purposes, that is to sav :-
