Royal Highness the Duke of Cornwall, in the occupation of Herbert Corner, and being No. 365 on the said Tithe Commutation Map, distant about 8 chains to the south-east of the highway leading from Englishcombe to Bath.

A service reservoir situate in the parish of Englishcombe, in the field numbered 413 on the said map, and before described, at a point between the said storage reservoir before described and the said highway, and about 2 chains to the

south-east of the said highway.

An aqueduct, conduit, or line of pipes, wholly in the parish and county aforesaid, commencing on land belonging or reputed to belong to His Royal Highness the Duke of Cornwall, and in the occupation of Herbert Corner, and numbered 390 on the said map, at the point at which a stream of water issues from a spring or drinking place, and situate about 5 chains to the south of the fence dividing the fields numbered 390 and 394A on the said map, and terminating at the service reservoir hereinbefore described.

An aqueduct, conduit, or line of pipes wholly in the parish and county aforesaid, commencing at a spring issuing from the ground in the wood called or known by the name of Vernham Wood, and terminating by a junction with the line of pipes hereinbefore firstly described at a point about 4 chains from the commencement of the

same.

An aqueduct, conduit, or line of pipes wholly in the said parish and county aforesaid, commencing on land belonging, or reputed to belong, to His Royal Highness the Duke of Cornwall, and in the occupation of Herbert Corner, and numbered 399 on the said map, at the point at which a stream of water issues from the hill, and situate about 10 chains to the east of the Englishcombe stream, and terminating by a junction with the line of pipes firstly hereinbefore described at a point about 5 yards to the west of the fence dividing the fields No. 406 and 401 on the said map.

An aqueduct, conduit, or line of pipes wholly in the parish and county aforesaid, commencing on land belonging, or reputed to belong, to His Royal Highness the Duke of Cornwall, and in the occupation of Herbert Corner, and numbered 324 on the said map, at a point about 8 chains to the south-west of the house known as Kilkenny, and terminating at the storage reservoir firstly

hereinbefore described.

An aqueduct, conduit, or line of pipes wholly in the parish and county aforesaid, commencing on land belonging, or reputed to belong, to His Royal Highness the Duke of Cornwall, and in the occupation of Herbert Corner, numbered 362 on the said map, at a point at which a spring or stream of water issues from the hill, being about 2 chains to the south-east of the highway from Englishcombe to Bath, and terminating at the service reservoir hereinbefore mentioned.

An aqueduct, conduit, or line of pipes commencing at the service reservoir hereinbefore described, and terminating in the parish of Twerton-upon-Avon, at a point on the west side of and near to the Somerset and Dorset Railway Bridge over the highway from Bath to Twerton, which said aqueduct, conduit, or line of pipes will pass from, in, through, or into the parishes of Englishcombe and Twerton-upon-Avon, both in the county of Somerset.

To authorise the undertakers to take and impound water from certain springs issuing from the ground on lands situate in the parish of Englishcombe and county of Somerset, and numbered on the said tithe commutation map Nos. 390, 380s, 399, 362, and 324 in such parish, and

all such waters as may be found in, upon, or under any lands acquired by the undertakers.

To empower the undertakers to supply water for public, trading, domestic, and other purposes, to the inhabitants, public bodies, and other persons within the district, being the parish of Englishcombe, and such part of the parish of Twerton-upon-Avon aforesaid, as is not now supplied by the Corporation of the City of Bath under their Water Acts, or some part or parts thereof respectively. And also to empower the undertakers to supply water in bulk beyond those limits by agreement.

To empower the undertakers to construct and maintain in the parishes and aforesaid approaches, roads, and ways, embankments, mains, pipes culverts, cuts, drains, sluices, engines, filter beds, wells, tanks, valves, weirs, meters, and all other works and appliances and conveniences necessary in connection with the before-mentioned works, and for collecting, pumping, cleansing, storing, purifying, and distributing the water so to be

collected, pumped, and distributed.

To enable the undertakers to deviate from the line of works both vertically and horizontally.

To empower the undertakers to lay down and maintain pipes, culverts, and other works in, over, under, or across, and to cross, break, open, alter, divert, or stop up, for the purposes of the said intended works, either temporarily or permanently, any turnpike roads, highways, footpaths, private roads, streets, bridges, canals, towing paths, railways, tramways, sewers, drains, rivers, streams, brooks, and watercourses in the said parishes before mentioned.

To empower the undertakers to purchase and take by agreement any lands, houses, springs, streams, wells, waters, and other hereditaments or easements, requisite or desirable for the purpose aforesaid, and to acquire waylenves, waterleaves and easements in or over the same, and to confer vary or extinguish any rights, easements, or privileges connected therewith which would in any way interfere with the objects and purposes of the

said Provisional Order.

To empower the undertakers to exercise all such powers, rights, and privileges as are usually conferred upon Water Companies, or which may be necessary or expedient for carrying into execution any of the objects and purposes of the undertaking and the objects and purposes of the said Provisional Order.

To empower the undertakers to make proper provisions for the prevention of waste, illegal use, obstruction or misuse, or wrongful use of the waters supplied, and to make and adopt proper and needful bye-laws and regulations in reference thereto and to enforce the same by penalties or otherwise.

To empower the undertakers to demand, take, and recover rates, rents, and charges, and to grant exemptions therefrom, and to make special contracts, agreements. and charges for the supply of water, and to confer other rights and

privileges.

To incorporate with the intended Provisional Order all or some of the powers and provisions of "The Lands Clauses Consolidation Acts, 1845, 1860, and 1869," The Companies Clauses Act, 1845," "The Companies Clauses Act, 1863," "The Companies Clauses Act, 1869," "The Waterworks Clauses Act, 1847," and also such parts of "The Railways Clauses Consolidation Act, 1845" as relate to the roads and the temporary occupations, and to other matters as may be deemed expedient, and to extend, amend, alter, or repeal the provisions, or some of the provisions of an Act passed in the 9th and 10th years of the reign of Her present Majesty, intituled
