Railway No. 7, wholly in the township of Whickham and parish of Whickham, commencing by a junction with the Tanfield Branch Railway, belonging to or occupied by the North Eastern Railway Company and others, to the west of Dunston Forge, at a point 10½ chains, or thereabouts, south-west of the point where the Team Colliery wagon-way crosses the said Tanfield Branch Railway, on the level at or near Norwood Colliery, and terminating by a junction with the said intended Railway No. 2, hereinbefore described, at a point 5 chains or thereabouts northward of the point where the said Team Colliery wagon-way crosses the Tanfield Branch Railway.

Railway No. 8, commencing in the township No. 25534.

of Whickham, and parish of Whickham, to the southward of St. Omer's Haugh, on the site of the Team Colliery wagon-way, near the northernmost of the disused staiths connected therewith, abutting on the River Team and terminating in the township of Gateshead, in the parish and borough of Gateshead, on the southern foreshore of the River Tyne, at or near the line of low water mark, 1 chain or thereabouts eastward of the centre of the River Team, where it flows into the River Tyne.

Railway No. 9, commencing by a junction with the intended Railway No. 2 herein-before described, at the point of junction therewith of Railway No. 8 lastly herein-before described, and terminating in the township of Gateshead, in the parish and borough of Gateshead, on the southern foreshore of the said River Tyne, at or near the line of low water mark at a point 10 chains or thereabouts eastward of the centre of the said River Team where it flows into the River Tyne.

Railway No. 10, commencing in the township of Whickham, in the parish of Whickham, by a junction with the Redheugh Line of the North Eastern Railway, formerly the Newcastle and Carlisle Railway, at a point 2½ chains or thereabouts west of the bridge carrying the said railway over the River Team at Dunston, and terminating in the said township and parish by a junction with the said intended Railway No. 2, hereinbefore described, on the site of the said Team Colliery wagon-way at a point 3½ chains, or thereabouts south of the said northernmost of the disused staiths hereinbefore referred to.

Railway No. 12, wholly in the township of Winlaton, in the parish of Byton, commencing by a junction with the Consett Line of the North Eastern Railway at a point 16½ chains or thereabouts measured in a south-easterly direction along the said Consett Railway from the centre of the bridge carrying the said Consett Railway over the Blaydon Main Colliery wagon-way, and terminating by a junction with the said Redheugh Line of the North Eastern Railway at a point 2 chains or thereabouts measured in an easterly direction along the said Redheugh Line from the centre of the bridge carrying the said Redheugh Line over the road leading from Scotswood to Shotley Bridge.
