43. To alter, amend, extend, and if need be to repeal, or to repeal, consolidate, and re-enact with or without amendment all or some of the powers and provisions of the following Acts, or Provisional Orders confirmed by Parliament, or any of them, so far as the same are now in force relating to the city, that is to say: the Act 44 George III., cap. 58; the Act 7 and 8 George IV., cap. 86; the Act 13 Vict., cap. 19; the Carlisle Improvement Act, 1873; the Provisional Order of the General Board of Health, dated July 31, 1850; the Provisional Orders of the Local Government Board, dated respectively March 2, 1876, and May 27, 1884; and the Carlisle Electric Lighting Order, 1883; and of all Charters and of all other Acts of Parliament and Provisional Orders confirmed by Parliament relating to the City or the Corporation, or which it may be necessary to alter, amend, extend, or repeal in order to effect the objects of the Bill.

44. And notice is hereby further given, that on or before the 30th day of November instant, a map in duplicate showing as well the present boundaries of the City as the boundaries of the proposed extension thereof, will be deposited for public inspection with the Town Clerk of Carlisle, at his office at No. 15, Fisher-street, in the said city, at all reasonable hours.

45. Printed copies of the Bill will be deposited in the Private Bill Office of the House of Commons on or before the 21st day of December next.

Mountain Ash Local Board (Gas, Water, &c.).  
(Powers to Mountain Ash Local Board to construct and maintain Gas Works and Water Works; to manufacture Gas and Residual Products and to supply Gas and Water within their District; Purchase of Lands and Easements for Gas and Water Works compulsorily and by Agreement and use of lands for Gas Works purposes; to take and impound water from the River Clydach and to take, appropriate, and impound the streams called Nant-yr-Ysfa and Nant-Sych and other tributary streams of the River Clydach; to purchase by Agreement and to maintain the Water Works, undertaking rights, and privileges of the Penrikyber Gas and Water Company Limited, and to dissolve that Company; to purchase by Agreement the Water Works, Gas Works, main pipes, and other works and apparatus belonging to Nixon's Navigation Company Limited, used for the supply of Gas and Water or either of them, or some part or parts thereof, respectively; Manufacture storage and supply of gas and conversion and sale of residual products; Laying of Gas and Water mains and pipes and opening of roads, &c.; Defining limits of supply of Gas and Water; Rates, rents, and charges; Bye-laws and penalties; Agreements with Local and other Authorities,

bodies, and persons as to supply of Gas and Water or either of them in bulk; Agreements with and powers to Penrikyber Gas and Water Company Limited and Nixon's Navigation Company Limited; Amendment or Repeal of provisions of "The Pontypridd Gas Act, 1850," and of "The Pontypridd Waterworks Act, 1864," respectively authorising the Pontypridd Gas-light and Coke Company to supply Gas and the Pontypridd Waterworks Company to supply water in the Parish of Llanwonno; Transfer to and vesting in Local Board of the Workman's Hall, Mountain Ash, and powers to Local Board to maintain and alter, &c., the said Hall; Dissolution of the Mountain Ash Workman's Hall Company Limited; Transfer to and vesting in Local Board of the Burial Ground belonging to the Burial Board for the consolidated Chapelry of St. Margaret's, Aberdare, in the County of Glamorgan, and of the powers, duties, and liabilities pecuniary and otherwise, of the said Burial Board, and dissolution of the said Board; To levy General and Special District and other Rates for the purposes of the Bill; To apply funds and borrow money and other money powers; To grant Annuities, issue Debentures, and other Securities; Apply Rates; Incorporation and Amendment of Acts; and other purposes.)

NOTICE is hereby given, that application is intended to be made to Parliament in the ensuing Session by the Local Board for the District of Mountain Ash, in the County of Glamorgan (being the Urban Sanitary Authority for the said District, and hereinafter called the "Local Board"), for leave to bring in a Bill for effecting the following or some of the following objects and purposes (that is to say):—

1. To confer upon the Local Board all needful powers for manufacturing gas, and for supplying water and gas, or either of them, for all purposes public and private within the following limits (that is to say):—So much and such parts of the Parishes of Aberdare and Llanwonno respectively, both in the county of Glamorgan, as are comprised within the District of the Local Board.

2. To authorise the Local Board to construct and maintain the several water and other works hereinafter mentioned, or some of them, all of which will be wholly situate in the parish of Llanwonno, in the county of Glamorgan (that is to say):—

Work No. 1. A reservoir (to be called the Clydach Reservoir) to be formed by an embankment, commencing at or near a point in a field belonging or reputed to belong to David Walters and Griffith Griffiths, as trustees under the will of Walter Walters, deceased, and in the occupation of John Evans, and numbered 174, in the said parish of Llanwonno, on the Ordnance Survey scale  $\frac{1}{25000}$ , situate  $4\frac{1}{2}$  chains or thereabouts from the southerly corner of the said field, and 1 chain or thereabouts north of the southerly fence of the said field, and extending thence in a south-westerly direction a distance of 5 chains or thereabouts, and terminating in a field belonging, or reputed to belong, to Evan Llewellyn and David Llewellyn, and in the occupation of David Llewellyn, and numbered 179 on the said Ordnance Survey, at or near a point in the said field situate 22 chains or thereabouts eastward of Darwonno Farmhouse, and which reservoir will be situate partly on lands forming part of Darwonno Farm, belonging, or reputed to belong, to Evan Llewellyn and David Llewellyn, and in the occupation of David Llewellyn, and partly on lands forming part of Pistyll Goleu Farm, belonging or reputed to belong to David Walters and
