The intended tramways will be made and pass from, in, through, or into the following townships, parishes, districts, or places of Birming-ham, Edgbaston, Aston, and Saltley, in the county of Warwick, Handsworth and Harborne, in the county of Stafford, and King's Norton, Northfield, and Balsall Heath, in the county of Worcester.

The tramways will be constructed on a gauge of 3 feet 6 inches, or such other gauge as may be authorised by the Board of Trade, with such grooves, plates, or tubes as may be necessary to work the same upon the cable system or otherwise, and power will be sought to authorise the Company on every or any such tramways as aforesaid, to use engines, carriages, or cars of any width, not exceeding 6 feet 3 inches. It is not intended to run on the tramways carriages. or trucks adapted for use on railways.
