(Application under "The Gas and Waterworks Facilities Act, 1870," to the Board of Trade for Provisional Order for new Waterworks; Extension of Limits of Supply; Additional Lands; Additional Capital; Amendment of Act.)

OTICE is hereby given, that the East Wcrcestershire Waterworks Company (hereinafter referred to as "the Company' (nereinatter referred to as "the Company") are about to apply to the Board of Trade under "The Gas and Waterworks Facilities Act, 1870," for a Provisional Order to be confirmed by Parliament in the ensuing session, and that by such Order the Company will seek for powers for the following or some of the following, among other purposes (that is to say):

1. To authorise and empower the Company, in the county of Worcester, to construct and main-

tain the following works, namely:-

(1.) An aqueduct, conduit, or line of pipes (No. 1) in the parishes or places of Bromsgrove, Graften Manor, Stoke Prior, Upton Warren, Dodderhill, Droitwich, St. Nicholas, St. Andrew, St. Peter, Salwarpe, and Martin Husingtree, or some of them, commencing in the said parish of Bromsgrove by a junction with the existing line of pipes of the Company in the main road leading from Bromsgrove to Worcester, 2 chains and a half or thereabouts measuring along that road in a northeasterly direction from the mile-post thereon denoting 12 miles to Worcester and 1 mile from Bromsgrove, and terminating in the said parish of Martin Husingtree, in the said road where the south-western boundary of the said last-mentioned parish crosses the

(2.) An aqueduct, conduit, or line of pipes (No. 2) commencing by a junction with the saidolastly before described conduit at the termination thereof, and terminating in the parish of Claines in the said road, opposite the Alma Inn, Barbourne, kept by Josiah Rice, which conduit will be situate in the parishes or places of Martin Husingtree, Hindlip, Claines, Fernhill Heath, Barbourne, and Worcester, or some or one of them.

5. To enable the Company within the extended limits of supply to take, demand, and levy rents, rates, and charges for the supply of water, and to exercise all such rights, powers, and privileges, as they have or may exercise within their existing

district for the supply of water.

To authorise the Company, and the mayor, aldermen, and citizens of the city of Worcester, and any other Corporation, public hody, or sanitary authority, within or adjoining the Company's limits of supply, to make and carry into effect contracts and agreements for the supply of water in bulk or otherwise.

7. To constitute the said intended works for all purposes part of the undertaking of the Com-

pany.

8. To enable the Company to deviate from the lines and levels shown on the deposited plans and sections to any extent defined in the proposed

To authorise the Company to lay down and maintain pipes and apparatus in, over, and across, and for that purpose to break up, alter, divert, stop up, and interfere with streets, reads, lanes, rivers, watercourses, streams, railways, tram-ways, sewers, drains, bridges, pipes, and telegraph apparatus.

10. To enable the Company to acquire by agreement, and to hold lands, easements, water, and property for the purposes of the Order and

11. To enable the Company to apply their existing funds, and any moneys which they have still powers to raise, to the purposes or any of the purposes of the Order, and for the purposes thereof and of their undertaking generally, to raise additional capital by new, ordinary, and preference

shares, or by either of those modes, and by loan.

The Order will vary and extinguish allexisting rights and privileges which would interfere with any of its objects, and will conference. upon the Company all such other rights and privileges as may be necessary for any of the purposes of the Order, and will amend, enlarge, and repeal the necessary powers and provisions of "The East Worcestershire Waterworks Act, 1877," and of every other Act relating directly or indirectly to the Company or their undertaking, and will incorporate with itself, with or without varia-
