PRESENTATIONS.

Any Lady who proposes to be presented must leave at the Lord Chamberlain's Office, St. James's Palace, before twelve o'clock, two clear days before the Drawing Room, a card with her name written thereon, and with the name of the Lady by whom she is to be presented. In order to carry out the existing regulations, that no presentation can be made at a Drawing Room excepting by a Lady actually attending that Court, it is also necessary that an intimation from the Lady who is to make the presentation, of her intention to be present, should accompany the presentation card above referred to, which will be submitted to The Queen for Her Majesty's approbation. It is Her Majesty's command, that no presentations shall be made at the Drawing Rooms, except in accordance with the above regulations.

It is particularly requested that in every case the names be very distinctly written upon the cards to be delivered to the Lord Chamberlain, in order that there may be no difficulty in aunouncing them.

It is not expected that Gentlemen will present themselves at the Drawing Rooms, except in attendance on the Ladies of their families.

Any Nobleman or Gentleman who proposes to be presented, must leave at the Lord Chamberlain's Office, St. James's Palace, before twelve o'clock, two clear days before the Levee, a card with his name written thereon, and with the name of the Nobleman or Gentleman by whom he is to be presented. In order to carry out the existing regulations that no presentation can be made at a Levee excepting by a person actually attending that Levee, it is also necessary that an intimation from the Nobleman or Gentleman who is to make the presentation, of his intention to be present, should accompany the presentation card above referred to, which will be submitted to The Queen for Her Majesty's approbation. It is Her Majesty's command that no presentations shall be made at Levees, except in accordance with the above regulations.

THE Board of Trade have received through the Secretary of State for Foreign Affairs a copy of a Despatch from Her Majesty's Ambassador at St. Petersburg, inclosing the following translation of a Notice issued by the Russian Government, viz. :-

The Official Gazette of the 17th-29th January, 1886, contains the following Notification :-

THE Governor-General of Odessa, having received information of the cessation of cholera since the 14th-22nd December last at the ports of Trieste, as also at Algiers and Tunis, issued orders on the 9th-21st instant to the quarantine establishments of the Black Sea to discontinue the seven and fourteen days observation of vessels arriving from ports of the Austrian littoral of the Adriatic, as also from those of Algiers and Tunis, and only to subject these vessels to strict medical inspection in accordance with the requirements of the Quarantine Code. This measure may also be extended to such vessels already in Russian Black Sea ports as may have left the above-mentioned ports with a clear bill of health after the 28th Herember, 1886. THE Board of Trade have received through the Secretary of State for Foreign Affairs the following translation of a Notice issued by the Danish Government, viz. :-

The Proclamation issued on the 8th of August last year by the Ministry of Justice, prescribing quarantine upon all ships from French Mediterranean ports and from all Spanish ports is hereby revoked, in as far as French Mediterranean ports are concerned.

Moreover, the Proclamation issued by the Ministry of Justice, on the 12th September last year, imposing quarantine on ships from ports in Sicily, is also revoked.

At the same time the provisions contained in clause II, section I, of the Act of the 2nd of July, 1880, or preventing the introduction of contagious diseases into Denmark shall, until further notice, be put in force with respect to ships coming from or that have been in communication with French Mediterranean ports, or harbours in Sicily, or that have received persons from or have had persons on board such ships.

This Order shall take effect immediately.

- To the Churchwardens and Overseers of the Poor of the several parishes comprised in the said Union ;—

And to all others whom it may concern.

WE, the Local Government Board, in pursuance of the powers given to Us by the Statutes in that behalf, hereby Order, with respect to the relief of the Poor in the said Hitchin Union, as follows :---

ARTICLE 1.—Subject to the provisions of the General Order of the Poor Law Commissioners, dated the twenty-first day of December, one thousand eight hundred and forty-four, in force in the Union, every able-bodied male pauper who receives relief within the Union, and is relieved out of the Workhouse, shall be relieved in the following manner; that is to say :— Half at least of the relief given to such pauper

Half at least of the relief given to such pauper shall be given in food, clothing, and other articles of necessity.


No such pauper shall receive relief from the Guardians, or any of their officers, or any Overseer of any Parish in the Union, while he is employed for wages or other hire or remuneration by any person; but every such paper so relieved shall be set to work by the Guardians.

ARTICLE 2.—The Guardians shall, within fourteen days after the day when this Order comes into force, and from time to time afterwards as the Local Government Board may require, report to the Local Government Board the place or places at which able-bodied male paupers shall be so set to work in the Union, the sort or sorts of work in which they or any of them shall be employed, the times and mode of work, and all such other matters relating to the employment of such able-bodied paupers as the said Guardians shall deem material to be communicated to the Local Government Board, or as the Local Government Board shall require.

ARTICLE 3.—If the Guardians shall depart, in any particular instance, from any of the regulations hereinbefore contained, and shall, within fifteen days after such departure, report the same and the grounds thereof to the Local Government Board, and if the Local Government Board shall approve of such departure, then the relief granted in such particular instance shall, if otherwise lawful, not be deemed to be unlawful, or be subject to be disallowed.

And whereas provision is made in a General Order of the Poor Law Commissioners, bearing date the twenty-tourth day of July, one thousand eight hundred and forty-seven, in force in the said Union, for the appointment of an officer, to be termed a Superintendent of Outdoor Labour, and for the continuance in office of such officer, and it is expedient that further provision should be made as hereinafter mentioned; We therefore further Order, that if at any time the number of able-bodied male paupers requiring relief shall be so small as to render the services of a Superintendent of Out-door Labour unnecessary, the Guardians may dispense with the services of such an officer.
