NOTIFICATION respecting the Fee to be levied for the Registration of every British Subject, or British Protected Subject, residing within a Consular District on the West Coast of Africa, under the Order in Council of 26th March, 1885.

HEREAS by the West Africa Order. 1885, it was provided that every person, on every registration, should pay a fee of such amount as the Secretary of State from time to time might appoint; and that the amount of the fee might be uniform for all persons, or might vary according to the position and circumstances of different classes, if the Secretary of State from time to time should so direct ; but that it should not in any case exceed five shillings.

Now, therefore, I, the undersigned, one of Her Majesty's Principal Secretaries of State, do hereby direct that, until further orders, the fee for the registration of any British subject, or any British protected subject, under the above-recited Order shall be fixed at five shillings.

Foreign Office, March 3, 1886. BRITISH CLAIMS AGAINST MEXICO.

THE Earl of Rosebery, Her Majesty's Principal Secretary of State for Foreign Affairs, has received from Her Majesty's Minister at Mexico, a Despatch, dated the 28th of January, inclosing a notification from the Mexican Minister for Foreign Affairs, announcing that the President of the Republic has appointed General Don Felix B. Berriozabal to make a preliminary examination of all the claims which have been presented up to this time against the Government of Mexico.

Mr. L. E. G. Carden, Her Majesty's Consul at Mexico, has, with the concurrence of the Mexican Government, been appointed British Representative to assist General Berriozabal in making such preliminary examination and investigation.

The following is the English text of the Article of the Preliminary Agreement for the renewal of relations between Great Britain and Mexico, signed in the city of Mexico on the 6th of August, 1884, which bears upon the subject :-

"The Mexican Government will order an impartial investigation to be made with respect to all the pecuniary claims of British subjects, based on acts of the Federal Government of Mexico anterior to the exchange of the ratifications of these preliminaries, and will provide for the liquidation of the amounts which may be found to be due to them, as well as for the payment of those already recognised by the same Federal Government."

Notice is accordingly hereby given, that all persons having claims against the Government of Mexico, coming within the scope of the present enquiry, should present and forward the same, together with the necessary proofs or vouchers in respect thereof for examination, either direct to Mr. Carden, at Her Majesty's Legation in Mexico, or to the Foreign Office in London, addressed to Her Majesty's Principal Secretary of State for Foreign Affairs, for transmission to Mexico, within six months from the date of the present notification, after which date no further communication upon the subject of such claims can be received.
