Windsor Castle, March 19, 1886.

THIS day the Archbishop of Canterbury, accompanied by the Bishops and Clergy of the Province, waited upon Her Majesty to present the following Address, which was received by Her Majesty on the Throne:—

To the QUEEN's Most Excellent Majesty,
&c., &c., &c.

Madam,

1. WE, Your Majesty's faithful subjects, the Archbishop, Bishops, and Clergy of the Province of Canterbury in Convocation assembled, approach Your Majesty with the assurance of our dutiful and affectionate attachment to Your Majesty's Throne and Person.

We rejoice that it has pleased Almighty God to keep Your Majesty in health and strength since we last had the honour of addressing the Throne, and we pray that Our Heavenly Father may long continue Your Majesty's happy reign over a loyal and united people.

2. We desire to offer our humble and heartfelt congratulations on the marriage of Her Royal Highness the Princess Beatrice, which has been solemnized since we last approached Your Majesty, and we pray that God's blessing may ever rest on Her Royal Highness and the Prince her husband, and that their happiness may be a source of lasting happiness to Your Majesty.

3. We rejoice that of the six new Sees, the foundation of which has been authorized by Your Majesty, with the advice and consent of the Lords Spiritual and Temporal and the Commons in Parliament assembled, two more (the Sees of Newcastle and Southwell) have been endowed by the munificence of Your Majesty's subjects since the first meeting of the last Convocation, so that only one is now wanting to complete the number; and that a further extension of the Home Episcopate has been sanctioned by a recent Act of the Legislature, providing for the separation of the ancient Sees of Gloucester and Bristol; and we desire to thank Your Majesty for having graciously concurred in the arrangements which have thus provided for the more efficient discharge of the duties of the Episcopal office.

Your Majesty has been graciously pleased to accept copies of the completed revision of the authorized version of the Old and New Testaments, a work which we trust will be of great service to all English speaking people in the understanding of many passages of God's Holy Word.

It is our humble prayer and confident hope that although the vast increase of the population throws enormous difficulties in the way of the beneficent labours of the Church, yet the self-denying zeal of Churchmen and others, seconded by the exertions of the Clergy, may, under the blessing of Almighty God, be successful in securing the continued attachment of the people to the Church of their fathers.

We pray that the blessing of Our Heavenly Father may rest upon Your Majesty, and upon every member of Your Royal house.

THE Board of Trade have received through the Secretary of State for Foreign Affairs a copy of a Despatch from Her Majesty's Consul at Copenhagen, enclosing the following translation of a notice issued by the Danish Government, viz. :—

The Proclamations issued on the 11th November, 1885, and on the 3rd of February last, whereby quarantine was ordered with respect to ships coming from Tunis and from Venice, respectively, are hereby revoked.

Whereas the provisions contained in clause II, section I, of the Act of the 2nd of July, 1880, for preventing the introduction of contagious diseases into Denmark, shall, until further notice, be put in force with respect to ships coming from or that have been in communication on the voyage with ships from one of the said places.

Quarantine, in accordance with the above, is ordered with respect to the following places :

French ports between Nantes and Cherbourg.

All Spanish ports and Gibraltar.

The provisions contained in clause II, section I, of the Act of the 2nd of July, 1880, for preventing the introduction of contagious diseases into Denmark, are in force with respect to the following places :

French ports between Cherbourg and the Belgian frontier.

All French Mediterranean ports.

Italian Continental ports on the Gulf of Genoa, and the Sea of Tuscany.

All ports in Sicily.

Venice.

Tunis.

All ports in Egypt, harbours in the Red Sea, Fez, Mequinez, and Dar el Beida, in Morocco.

Rio de Janeiro.

Havana and all ports in Japan.

Prohibition against the importation into the Kingdom of used linen, used wearing apparel, used bed clothes (provided the said articles do not belong to a passenger's private effects), rags, used wadding, carding wool, paper refuse, hair, and skins is in force with respect to the following places :

All French ports.

Italian Continental ports on the Gulf of Genoa and the Sea of Tuscany, as well as Spanish Mediterranean ports.

Prohibition against the importation into Denmark of used linen, used wearing apparel, used bed clothes (provided the said articles do not belong to a person's private effects) is in force with respect to Rio de Janeiro and Havana.

With regard to the above it is specially commanded that linen, clothes, and bedding, which are brought by travellers from either of those two places, should be purified.

This Proclamation shall take effect immediately. To all whom it shall or may concern.

THE Board of Trade have received through the Secretary of State for Foreign Affairs a copy of a Despatch from Her Majesty's Consul-General at Constantinople, reporting that notwithstanding six full days quarantine is still imposed on arrivals from Spain and Venice and its neighbourhood, vessels arriving in Turkish ports from the above places with clean bills of health received at an intervening port free from cholera are admitted, after medical visit, to pratique provided an interval of 24 days have elapsed between the date of their departure from Spain and Venice and arrival in Turkey.
