Circular from the Imperial Royal Maritime Government to all the Officials and Functionaries of Ports and of Maritime Sanita-

By order of the Minister of Commerce, forwarded in a Despatch dated to-day, the Maritime Government decrees:

The reserve of observation of seven days, fixed by the circular of the 10th instant, No. 2625, with regard to persons arriving from Italy, is limited to the district between our frontier and the mouth of the Po di Govo inclusive, and reduced from that point to Ancona to forty-eight hours.

The present Decree applies to vessels upon the base of the reserve of observation laid down in the circular quoted above.

With regard to the precautional measures combined with these observations, the rules drawn up in the circular of the 13th of January, 1886, No. 564, still hold good. THE PRESIDENT.
