THE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Act, 1878, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

1. The Area described in the Schedule to this Order is hereby declared to be an Area infected with pleuro-pneumonia.

2. This Order shall take effect from and immediately after the ninth day of May, one thousand eight hundred and eighty-six. *C. L. Peel.*

SCHEDULE.

An Area in the county of Dorset, comprised within the following boundary, that is to say, commencing at the Sea by Chapmans Pool, along the highway direct to Kingston to the Lake forming the southern boundary of Corfe Common, along the said Lake westward and northward forming the boundary of the said Common direct to West Mill Bridge on the western side of Corfe Castle, continuing from the said Bridge direct to the south-east fence of Knowl Hill and continuing the said fence in a westerly direction to the Grange-road in the parish of Steeple, and from the last-mentioned road along the highway north of Steeple Church leading to Blackmanston Farm, and continuing the said highway direct to Kimmeridge and terminating at the Sea by the Kimmeridge Coast Guard Station.

SCHEDULE.

An Area in the Eastern Division of the county of Sussex, comprised within the following boundary, that is to say, commencing at the junction of the public-road leading from the late turnpike-road at the top of Five Ash Down in the parish of Buxted to The Rocks Farm in the said parish, and proceeding along the said public-road to the road from Buxted to Hurstwood near to The Rocks Farm, and thence northward by the last-

mentioned road to the Bridge over the stream at the foot of the Hill leading to Hurstwood, thence following the stream southward to Buxted Bridge and Hempstead Mill, both in the parish of Buxted, and to Uckfield Bridge in the parish of Uckfield, and thence by the said stream to the boundary of the parish of Uckfield with the parishes of Little Horsted and Isfield, and continuing across the fields in a line with the said Uckfield parish boundary to Buckham Hill and Shortbridge where the said parish of Uckfield adjoins the parish of Fletching, and thence by the said boundary of the said parish of Uckfield with the parish of Maresfield to the late turnpike-road at The Budletts in the said parish of Uckfield, thence across the said road and following the eastern boundary thereof to the eastern side of Maresfield Mill pond, and continuing along the said eastern side of the said pond and of the stream which supplies the same to the south-west corner of Hendall Wood, and along the southern hedge of the said Hendall Wood to its junction with the late turnpike-road at Five Ash Down aforesaid, and thence continuing in a northerly direction along the western side of the said road to the point opposite the junction of the said road at the top of Five Ash Down with the road leading to The Rocks Farm, and across the said late turnpike-road to the said road leading to The Rocks Farm.

(PORT OF LONDON—ROYAL ALBERT DOCK.)

By Her Majesty's Most Honourable Privy Council.

THE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Act, 1878, and of every other power enabling them in this behalf, do hereby define the following part of the Port of London as a foreign animals quarantine station (in this Order called the Quarantine Station):

All that space on the north side of the Royal Albert Dock, in the county of Essex, the property of the London and St. Katharine Docks Company, including so much of the roadway lying between the water-edge of the said Dock and the Goods Sheds running parallel thereto as extends from Shed No. 11 to Shed No. 19, and also including that part of Shed No. 19 forming the extreme west-end thereof, and which is divided off from the rest of the Shed.

And do hereby prescribe as follows:

1. When landed the animals shall forthwith be placed in that part of Shed No. 19 forming the extreme west end thereof, and shall be there kept until moved thereout in accordance with the regulations contained in Article 21 of The Foreign Animals Order of 1885.

2. When and so soon as an Inspector of the Privy Council shall have certified in writing that all parts of the Quarantine Station with which the animals or their droppings have come in contact in their passage to the said part of Shed No. 19 have been cleansed and disinfected to his satisfaction, all parts of the space above defined, other than the said part of Shed No. 19, shall cease to be included in the Quarantine Station, and thereupon, for the purposes of this Order, the said part of Shed No. 19 shall alone be deemed to be the Quarantine Station hereby defined.
