

THE CONTAGIOUS DISEASES (ANIMALS) TRANSFER OF PARTS OF DISTRICTS ACT, 1884.

THE Lords and others of Her Majesty's Most Honourable Privy Council approved on the 4th day of May, 1886, of an Agreement bearing date the 8th day of April, 1886, made between the Mayor, Aldermen, and Burgesses of the borough of Appleby of the one part, and the Justices in General or Quarter Sessions assembled of the county of Westmorland of the other part, whereby the jurisdiction, for the purposes of The Contagious Diseases (Animals) Act, 1878, of the whole of the district of the borough of Appleby, was, from and after the date of such approval by the Privy Council as aforesaid, transferred to the district of the county of Westmorland.
