Reverend Charles John Bishop of the said diocese of Gloucester and Bristol (testified by his having signed and sealed this representation) we the said Ecclesiastical Commissioners humbly represent that it would in our opinion be expedient that all that part of the said new parish of Saint Luke Barton Hill which is described in the schedule hereunder written, all which part, together with the boundaries thereof, is delineated and set forth on the map or plan hereunto annexed, should be assigned as a district chapelry to the said church called Christ Church Barton Hill as aforesaid, and that the same should be named 'The District Chapelry of Christ Church Barton Hill.

"And with the like consent of the said Charles John Bishop of the said diocese of Gloucester and Bristol (testified as aforesaid) we the said Ecclesiastical Commissioners further represent that it appears to us to be expedient that banns of matrimony should be published, and that marriages, baptisms, churchings, and burials should be solemnized or performed at the said church called Christ Church Barton Hill as aforesaid, and that the fees to be received in respect of the publication of such banns and of the solemnization or performance of the said offices should be paid and belong to the minister of the same church for the time being: Provided always, that nothing herein contained shall be construed as expressing any intention on the part of us the said Commissioners to concur in or approve the taking of any sec for the performance of the said office of baptism or for the registration thereof.

"We, therefore, humbly pray that Your Majesty will be graciously pleased to take the premises into Your Royal consideration and to make such Order with respect thereto as to Your Majesty, in Your Royal wisdom, shall seem meet.

"The SCHEDULE to which the foregoing Representation has reference.

"The District Chapelry of Christ Church

Barton Hill being:

"All that part of the new parish (sometime district chapelry) of Saint Luke Barton Hill situate partly in the city and county of the city of Bristol partly in the county of Gloucester and wholly in the diocese of Gloucester and Bristol wherein the present incumbent of such new parish now possesses the exclusive cure of souls which is bounded upon the east and upon the north by the consolidated chapelry or new parish of Saint Matthew Moorfields in the said county of Gloucester and in the diocese aforesaid, upon the north-west by the new parish of Saint Lawrence Bristol in the said city and county of the city of Bristol and in the diocese aforesaid and upon the remaining sides that is to say upon the south-west and upon the south-east by an imaginary line commencing upon the boundary which divides the said new parish of Saint Lawrence Bristol, from the new parish of Saint Luke Barton Hill aforesaid at the centre of the bridge which carries Richmond-road over the lower coal yard line of the Midland Railway (formerly called the Saint Philip's branch of the said Midland Railway) and extending thence south-eastward along the middle of the said Richmond-road for a distance of seventeen chains or thereabouts thereby passing over the line of the Bristol and Birmingham Branch of the said Midland Railway to the point where the same road joins Barton Hill-road at the northwestern end of the bridge which carries the same road over the Bristol and South Wales Union Line of the Great Western Railway, and continuing thence still south-eastward along the middle

of the last-described bridge to a point over the middle of the last-named line of railway and extending thence north-eastward along the middle of the same line of railway for a distance of eighteen chains or thereabouts to the centre of the bridge which carries Packhorse-lane over the same line of railway, and extending thence south-eastward along the middle of the last-named lane for a distance of six and a-half chains or thereabouts to its junction with Morleystreet, and extending thence north-eastward along the middle of the said street for a distance of six chains or thereabouts to its junction with Cobdenstreet, and extending thence in a direction due eastward and in a straight line for a distance of five and a quarter chains or thereabouts (thereby crossing the grounds attached to Moorfields House) to the boundary which divides the said new parish of Saint Luke Barton Hill from the consolidated chapelry or new parish of Saint Matthew Moorfields aforesaid."

And whereas the said representation has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the respective Registrars of the two several Registries of the said diocese of Gloucester and Bristol at Bristol and at Gloucester.
