WE, the Ecclesiastical Commissioners for England, in consideration of a benefaction, consisting of one hundred and sixty pounds sterling, which has been paid to us in favour of the consolidated chapelry and benefice (hereinafter called the benefice) of the Holy Trinity, Wealdstone, in the county of Middlesex, and in the diocese of London, do hereby, in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, sections five and eleven, grant and appropriate out of our common fund to the said benefice of the Holy Trinity, Wealdstone, to meet such benefaction, one other capital sum of one hundred and sixty pounds sterling, to be applicable towards defraying the cost of completing the parsonage or house of residence belonging to the
