SCHEME of the Local Government Board made under "The Municipal Corporations Act, 1883":-

Kenfig.—Local Government District of Margam. Rural Sanitary District of the Bridgend and Cowbridge Union.

To the Constable of the Castle, Portreeve, and Burgesses of Kenfig, in the county of Glamorgan :-

To the Guardians of the Poor of the Bridgend and Cowbridge Union, in the county of Glamorgan, being the Sanitary Authority for the Rural Sanitary District of that Union ;-

To the Local Board of the District of Margam, being the Sanitary Authority for the Urban Sanitary District of Margam, in the said county of Glamorgan:

And to all others whom it may concern. WHEREAS by section 3 of the Municipal

Corporations Act, 1883, it is enacted that on and

after the 25th day of March, 1886, or such later day, not after the 29th day of September, 1886, as Her Majesty in Council may in the case of any place or places appoint, the following provisions shall apply to each of the places mentioned in the schedules to that Act to which Her Majesty may not be pleased before the said day to grant a new charter; that is to say,-

(a.) The place shall not be a corporate town " or borough, and any municipal or other "corporation thereof existing under any charter or grant or prescription shall be dissolved;"

" (b.) All property of any corporation in the "place which is dissolved by this Act, or of any person as member or officer thereof, " or of any court or judge whose jurisdiction " is abolished by this Act, shall be applied "for the public benefit of the inhabitants of "the place in such manner as may be for "the time being provided by a scheme of "the Charity Commissioners, or, in a case "where a scheme is made by the Local Government Board, by that scheme, and " shall vest in such persons or body corporate " as may be specified in such scheme."

And whereas by section 7 of the said Act it is enacted as follows:-

"Where any part of any of the places mentioned "in any of the schedules to this Act is "comprised in the district of any Local Board or Improvement Commissioners, "whether established before or after the " passing of this Act, and Her Majesty is " is not pleased to grant a Charter to such "place, the Local Government Board, after " such local inquiry as they think expedient, " may, at any time before any Corporation " in the said place becomes abolished by this " Act, make such scheme as might be made " by the Committee of Council under Part " Eleven of the Municipal Corporations Act,

And whereas Kenfig is a place named in the First Schedule to the Municipal Corporations Act, 1883, and it is not intended to petition Her Majesty for the grant of a Charter of Incorporation for such place;

And whereas the said place is comprised partly in the said Urban Sanitary District of Margam (the Local Board of which district are hereinafter referred to as "the Local Board") and partly in the suid Rural Sanitary District of the Bridgend and Cowbridge Union (the Sanitary Authority of which District are hereinafter referred to as "the Rural Sanitary Authority");
And whereas the said Constable of the Castle,

Portreeve, and Burgesses of Kenfig are a body corporate under and by virtue of a charter or grant or prescription, and are in this Order referred to as "the Corporation";

And whereas it is expedient that a scheme for the adjustment of the powers, rights, privileges, franchises, duties, property, and liabilities of the Corporation should be made as hereinafter provided;

And whereas Her Majesty, by Order in Council on the 17th day of February, 1886, appointed and ordered that in the case of the said borough of Kenfig the later day in the above-recited provision of the Municipal Corporations Act, 1883, referred to, should be the 29th day of September, 1886:

Now therefore We, the Local Government Board, in pursuance of the powers given to Us by the Statutes in that behalf, hereby Order as follows :-

ARTICLE I .- This scheme shall come into

operation on the twenty-ninth day of September, one thousand eight hundred and eighty-six. Such date is herein referred to as the "commencement of this scheme."

ARTICLE II.—For the purpose of carrying this scheme into execution Trustees shall be appointed in accordance with the provisions hereinafter contained; that is to say,

1. The Trustees shall be twelve in number, and shall be called "The Trustees of the Kenfig

Corporation Property.'

2. The Trustees shall be competent persons resident in Kenfig or within a convenient distance therefrom, and shall be appointed by the following electing bodies respectively in the following proportions; namely,-

Four by the persons whose names shall be on the Burgesses' Roll hereinafter mentioned; Four by the Rural Sanitary Authority;

and

Four by the Local Board.

Provided that the following persons shall be the first Trustees under this Scheme, and shall be deemed to have been elected by the electing bodies hereunder named; namely,-

By the Persons named on the Burgesses' Roll.

1. Rees Rees, of Kenfig, Farmer.

- 2. John Griffith, of Kenfig Higher, Farmer.
- 3. Evan Howell, of Penymynydd, Kenfig, Farmer.
- 4. Thomas Thomas, of Kenfig Higher, Farmer.

By the Rural Sanitary Authority.

- 5. John Felton, of Pyle Cottage, Pyle.
- The Vicar of Pyle and Kenfig.
- 7. Rees Thomas, of Hall, Pyle.

- 3. Any Trustee who is adjudicated a bankrupt or is incapacitated to act, or who communicates in writing to the Trustees his wish to resign, or ceases to be qualified by residence as aforesaid, or fails to attend any meeting of the Trnstees during a consecutive period of two years, shall thereupon cease to be a Trustee, and the Trustees shall cause an entry to be made in their Minute Book at their next meeting of every vacancy occasioned thus, or by the death of any Trustee. Pending any vacancy in the body of Trustees, the surviving or continuing Trustees for the time being, not being less in number than four, may act for all purposes of this Scheme.
- 4. Notice of any vacancy in the body of Trustees shall, as soon as practicable, be given by the surviving or continuing Trustees to the proper electing body, and such electing body shall, within three calendar months from the receipt of the notice, or within such further time as may be approved by the Board of Charity Commissioners for England and Wales, by Resolution passed at a Meeting of which due notice has been given, appoint a person to fill such vacancy; and the appointment so made shall forthwith be reported by the electing body to the Trustees, and by the

Trustees to the said Board of Charity Commissioners.

5. The persons whose names shall be on the Burgesses' Roll hereinafter mentioned shall, from time to time as may become requisite, appoint one of their number to represent them for the purpose of receiving and giving notices, and to call meetings of them as an electing body.

ARTICLE III.—From and after the commencement of this Scheme all the property mentioned in the Schedule to this Order, together with any other property, real and personal, possessed by or vested in the Corporation or any person or body in trust for it, or any of its members as such, or applicable for the benefit or under the direction of the Corporation, or any of its members as such, shall be vested in the Trustees, and any fines, fees, or sums of money payable under Section 10, Sub-section 1, Sub-clause (d.) of the Municipal Corporations Act, 1883, shall be paid to the Trustees.

ARTICLE IV.—The Trustees shall stand possessed of the interest of the Corporation in Kenfig Common, referred to in the Schedule to this Scheme, Upon Trust as follows; that is to

say,—

1. To permit the persons whose names shall be on the Burgesses' Roll as Burgesses or Burgesses' Widows who now have, or as Burgesses' Sons or Widows who hereafter acquire, rights of pasture and of cutting fern on the said Common, to exercise and enjoy the rights aforesaid as fully and effectually, and for such time and in such manner as he or she, by any statute, charter, byelaw, or custom of the Corporation in force at the time of passing the Municipal Corporations Act, 1883, might or could have had, acquired, or enjoyed such rights, in case that Act had not been passed.

Upon the extinction of the aforesaid rights of all of the said Burgesses and Burgesses' Sons and Widows to allow all the inhabitant householders of the said place of Kenfig to

exercise such rights.

3. If at any time previous to the extinction of all the said rights as aforesaid, the number of persons entitled as aforesaid to exercise and enjoy the said rights shall fall below the number of persons so entitled on the formation of the Burgesses' Roll, to let a right or so many rights of pasture, and of cutting fern from year to year at the best rent that they can obtain for the same, so that the number of persons entitled to exercise and enjoy the said rights may, until such extinction as aforesaid, remain as near as may be the same.

ARTICLE V.—The Trustees shall stand possessed of the income derived from the property vested in them under this Scheme, including the rents received in respect of the letting of rights on Kenfig Common, and any fines, fees, or sums of money paid to them as aforesaid, but subject to the payment of any manorial or other rent in respect of Kenfig Common or any other of the property of the Corporation, Upon Trust to pay and apply the said income in the following manner; that is to say,—

 In payment of any interest, salaries, or other lawful expenses, payable under Section 10 (1.) [a.] of the Municipal Corporations Act, 1883, and of the proper costs, charges, and expenses of and incidental to the administration of this Scheme.

2. In payment to existing Officers of the Corporation who may by reason of the dissolution of the Corporation be deprived of any emolument or pecuniary profit, or any other profit of a pecuniary value, of such compensation for the same as the Trustees and such Officers may mutually agree upon, or, in case of difference, as may be determined by Us.

3. In payment annually of a sum of Eleven Shillings to each of the Burgesses or Burgesses' Sons or Widows who are entered on the Burgesses' Roll hereinafter mentioned as representing the Burgesses who were the original holders of parcels of the Common called Gwaunycimla or Le Rugge.

4. As regards the residue, to divide the same equally between the Burgesses and Burgesses' Sons and Widows entered on the Burgesses' Roll hereinafter mentioned as the persons entitled to a share in the surplus

income of the Corporation.

5. Provided that if at any time the number of persons entitled as aforesaid to share in the said residue shall be less than the number who were so entitled on the formation of the Burgesses' Roll, the said residue shall be divided into so many shares as there were persons entitled on the formation of the said Roll, and one share shall be paid to each of the said Burgesses and Burgesses' Sons and Widows, and the other shares shall be paid to a separate Account to be called the "Surplus Fund Account," and shall from time to time, unless applied as hereinafter mentioned, be invested, and the resulting income shall be carried to the same Account and invested in like manner.

ARTICLE VI.—The Surplus Fund may from time to time be applied by the Trustees in such manner for the sooner extinction of the interests of the Burgesses and Burgesses' Sons and Widows in the property vested in the Trustees by this Scheme, or in such other manner for the advantage of the said Place of Kenfig as We may, by Order, Direct or Approve.

ARTICLE VII.—Upon the extinction of the interest of all the said Burgesses and Burgesses' Sons and Widows in the property vested in the Trustees by this Scheme, the Trustees shall apply the said property and income arising therefrom, together with any accumulations of income or other property which may then be in their possession, in such manner for the advantage of the said Place of Kenfig as We may, by Order, Direct or Approve, subject to the provisions of Article IV. 3. of this Scheme.

ARTICLE VIII.—Every person claiming to be entitled as a Burgess, or Son or Widow of a Burgess, in accordance with the provisions of Section 10, Sub-section 1, of the Municipal Corporations Act, 1883, shall, on or before the expiration of two calendar months from the commencement of this Scheme, send to the Trustees his or her claim in writing, and future claims of Widows and Sons of Burgesses shall be similarly sent in on or before the First day of September in every year. The Trustees shall, within two calendar months after the expiration of the time for sending in claims, make out a Roll (to be called "the Bur-

gesses' Roll"), containing the names of all persons entitled, or who, if the said Act had not been passed, would have been entitled as resident Burgesses or Sons or Widows of Burgesses to a share in the surplus income of the Corporation, and specifying which of such persons represent the Burgesses who were the original holders of parcels in the Common called Gwaunycimla or Le Rugge; and such Roll shall from time to time be revised by the Trustees by striking out the names of such of the persons entered therein as have died or ceased to reside in the place, or being Widows have married again, and entering therein the names of any Sons or Widows who may be entitled to be entered therein.

The Trustees shall not make out the Roll until one calendar month after the expiration of the time for sending in claims, and public notice of the day for making out such Roll, and for revising the same, shall be given by the Trustees fourteen

days previously.

No person whose name shall once have been entered shall (if alive) be struck off the Roll on any revision, unless notice in writing be served on him or her, or left at his or her last known place of abode, at least seven days previously to the date fixed for such revision.

In the event of the interest of any Burgess or Son or Widow of a Burgess being purchased by the Trustees, the name of such Burgess or Son or Widow shall be struck off the Roll, and an entry of the purchase shall be made on the Burgesses' Roll opposite to the name of such Burgess or Son or Widow.

ARTICLE IX.—All liabilities which immediately before the commencement of this Scheme attached to and were enforceable against the Corporation or the property thereof shall attach to and be enforceable against the Trustees so far only as the property vested in the Trustees by this Scheme may extend to satisfy such liabilities, and no further.

ARTICLE X.—Any investigation, legal proceedings, or remedy in respect of any debt, liability, penalty, or forfeiture due to or incurred by or on behalf of the Corporation before the commencement of this Scheme may be continued, prosecuted, or enforced by or against the Trustees so far only as the property vested in the Trustees by this Scheme may extend, and no further.

ARTICLE XI.—The term "property" in this Scheme means and includes all property, real and personal, and all things in action, and all rights of common or commonable rights, and rights to toll, and all franchises, privileges, and rights which have any pecuniary value, and all charters, records, deeds, books, and documents, and includes any estate or interest, legal or equitable, in any property so defined.
