TREASURY WARRANT

WE, the Commissioners of Her Majesty's Treasury, in pursuance of the Acts relating to Her Majesty's Post Office, and in exercise of all powers enabling us in this behalf, do, by this Warrant, made on the representation of Her Majesty's Postmaster-General (testified by his signing the same), and under the hands of two of us, the said Commissioners, order, direct, and declare as follows :---

Interpretation Clause.

1. In this Warrant the expression "Parcel" means a postal packet which is posted as a parcel in accordance with the provisions of this Warrant, or any Warrant amending the same.

Places between which Parcels may be transmitted. 2. From and after the date when this Warrant

comes into operation parcels may, subject to the provisions of this Warrant, be transmitted by Post between the Cape of Good Hope and St. Helena.

Rates of Postage.

3. On all parcels transmitted by Post under this Warrant between Cape Town and St. Helena. there shall be charged and paid the following rates of postage, that is to say :-

On every parcel not exceeding one pound in

weight ten pence.

- On every parcel exceeding one pound and not exceeding eleven pounds in weight, for the first pound ten pence, and for every additional pound or fraction of a pound in weight ten pence.
- 4. On all parcels transmitted by Post under this Warrant between any place in the Cape of Good Hope (except Cape Town) and St. Helena, there shall be charged and paid the following rates of postage, that is to say :-

On every parcel not exceeding one pound in weight one shilling and two pence.

On every parcel exceeding one pound and not exceeding seven pounds in weight, for the first pound one shilling and two pence, and for every additional pound or fraction of a pound in weight one shilling and two pence.

Provisions of other Warrants to apply

5. Every such parcel shall be subject to the provisions of the respective Warrants of the Commissioners of Her Majesty's Treasury relating to the Parcel Post between the United Kingdom and the several places above mentioned, so far as such provisions are applicable.

Commencement of Warrant.

6. This Warrant shall come into operation on the first day of November, one thousand eight hundred and eighty-six.
