WE, the Ecclesiastical Commissioners for England, in consideration of a benefaction, consisting of a moiety of the value of a certain house and premises which are about to be permanently secured to the district chapelry and benefice (hereinafter called the benefice) of Saint Michael, Abertillery, in the county of Monmouth, and in the diocese of Llandaff, as a parsonage house for the same benefice, do hereby, in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, sections five and eleven, grant and appropriate out of our common fund to the said benefice of Saint Michael, Abertillery, to meet such benefaction, one capital sum of seven hundred and forty-five pounds sterling, to be paid by us as the consideration for the conveyance in fee simple to the said benefice of the house and premises hereinbefore mentioned.

In witness whereof, we have hereunto set our common seal, this fourth day of November, in the year one thousand eight hundred and eighty-six.

WE, the Ecclesiastical Commissioners for England, acting in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, sections five and eleven, do hereby, subject as hereinafter mentioned, grant to the Incumbent of the vicarage of Bramford Speke-with-Cowley, in the county of Devon, and in the diocese of Exeter, and to his successors, Incumbents of the same vicarage, one yearly sum or stipend of forty-five pounds, such yearly sum or stipend to be payable out of the common fund under our control, and to be calculated as from the first day of May, in the year one thousand eight hundred and eighty-six, and to be receivable in equal half-yearly portions, on the first day of May and on the first day of November in each and every year: And we do also hereby grant and appropriate out of our common fund to the said vicarage of Bramford Speke-with-Cowley, one capital sum of three hundred and sixty-six pounds fourteen shillings and seven pence, such capital sum to be applied by us in discharging the amount payable to the
