THE Board of Trade have received through the Secretary of State for Foreign Affairs a copy of a Despatch from the Austrian Ambassador in London, stating that the measures of precaution taken to prevent the introduction of cholera in Austria-Hungary from Italy have been abolished.

A copy of the circular published by the Maritime Authority of Trieste was also enclosed, stating that the reserve of observation established in Dalmatia, has been reduced to three days against arrivals from Fiume, and to five days against those from Trieste, the Austro-Illyrian coast, and the Croatian coast, maintaining at the same time certain measures of disinfection for persons on board vessels and their effects.
