To alter, amend, extend, and enlarge, or to repeal, so far as may be necessary for the purposes of the Bill, the provisions of 9 and 10 Vic. cap. 335, and all other Acts relating to, or affecting the Cornwall Railway Company.

And notice is hereby also given, that a plan and section in duplicate of the proposed rail-ways, a plan in duplicate of all lands which may be taken under the compulsory powers of purchase to be inserted in the intended Act, a book of reference to the plans and a copy of the ordnance map, showing the general course or direction of the intended railways, will be deposited for public inspection with the Clerk of the Peace for the county of Cornwall at his office at Bodmin, and that a copy of so much of the said plan, section, and book of reference as relates to any parish or extra parochial place will be deposited for public inspection as follows (that is to say), in the case of a parish with the Parish Clerk of such parish at his residence, and in the case of an extra parochial place with the Parish Clerk of some parish immediately adjoining thereto at his residence. Each such deposit will be made on or before the 30th day of November, 1886, and

(Power to Local Board to Produce and Supply Electricity; Purchase of the Undertaking of the Cockermouth Gas Light and Coke Company by agreement or compulsorily, and Winding-up and Dissolution of the Company; Power to Local Board and Company to make Agreements; Power to Local Board to Make and Supply Gas and Convert Residual Pro-ducts, to Break up Streets, to Levy Rates, and Borrow Money; Providing for Transfer to other Local Authorities of Parts of Undertaking, with Power to them to carry on same and Levy Rates and Borrow Money; Incorporation of Acts; and other Purposes.) PPLICATION will be made to Parliament in

the ensuing Session thereof by the Local Board of Health for the district of Cockermouth, in the county of Cumberland (hereinafter called " the Local Board"), for leave to bring in a Bill for the following or some of the following 

supply electricity for all purposes within the limits hereinafter defined, and for that purpose on any land for the time being belonging to or occupied by them, to make and maintain works for the production, storage, supply, and distribution of electricity for the purposes of light, heat, and motive power, and to exercise with respect thereto all or any of the powers of the Electric Lighting Act, 1882, and the Gas Works Clauses Act, 1847, and the Gas Works Clauses Act, 1871, and such other rights and powers as may be necessary or expedient for the purposes aforesaid. 2. To authorise the Local Board to purchase,

and to transfer to and vest in, or to provide for the transfer to and vesting in them of the undertaking, lands, mains, pipes, machinery, stock-intrade, plant and property, powers, rights, and

easements, which at the date of the transfer may belong to the Cockermouth Gas Light and Coke Company (hereinafter called "the Company"), or of so much or such part thereof as may be defined by the Bill, and to authorise and require the Company to sell and transfer their Undertaking, property, and rights accordingly, or such part thereof as aforesaid, for such price and consideration, and upon such terms and conditions as have been or may, prior to the passing of the Bill, be agreed upon, or as may be settled by arbitration, or as may be provided for by the Bill, or prescribed by Parliament.

3. To provide for the discharge of the debts and liabilities, and the distribution of assets, and the winding up and dissolution of the Company.

4. To confer upon the Local Board all necessary powers for lighting and supplying electricity and gas within the following limits, that is to say :-

So much of the parishes of Brigham, Bridekirk, Isel, and Dean, in the county of Cumberland, or one of them, as lies within a radius of four miles from the Cockermouth Court House, or some parts or part thereof res-

pectively. To enable the Local Board, subject to the 5. provisions of the Bill, to carry on the Undertaking of the Company, and to exercise within the said limits the powers and privileges usually conferred on Gas Companies or Local Authorities making or supplying gas, or necessary for or incident to the business of a Gas Company, and to maintain, alter, extend, renew, and improve the existing gasworks of the Company and works for the manufacture, conversion, utilization, and distribution of materials used in or about the manufacture of gas, and of residual products resulting therefrom, and to manufacture and store gas, and to manufacture, convert, utilize, store, and dispose of such materials and products.

6. To empower the Local Board to manufacture, purchase, hire, sell, and let on hire, meters, stoves, ranges, engines, machines, burners, lamps, fittings, and other apparatus used for the production, storage and supply of electricity and for the supply or consumption of gas for any

7. To enable the Local Board to acquire, hold, and use patent rights and licences for and in relation to the production, storage and supply of electricity, the manufacture, supply and use of gas, and the manufacture and conversion of residual materials and products.

8. The lands to be used by the Local Board for the purposes of the manufacture of gas and the manufacture and conversion of such materials and products, are the following lands, namely :-

- (1.) A plot of land containing 2,972 square ards or thereabouts belonging or reputed to belong to the Company, situate in the said township of Cockermouth, and bounded on the north in part by Derwent-street, and in other part by property of or reputed to belong to Mary Ann McAdam, on the east by land of or reputed to belong to John Dodgson, on the south by land of or reputed to belong to the trustee of the late Anne Mawson, and on the west by land of or reputed to belong to John Sanderson Mawson.
- (2.) A plot of land containing 303 square yards or thereabouts belonging or reputed to be-long to the Company, situate in the said township of Cockermouth, and bounded on the north in part by property of or reputed to belong to Joseph Allison, and in other part by property of or reputed to belong to
